Road No. 585: Commencing at the northwest corner of the south half $S_{\overline{Z}}^{1}$) of the southwest quarter $(SW_{\overline{A}}^{1})$ of Section 3, Tp. 5 South, Range 39, E. W. M.; thence in an easterly direction one thousand nine hundred twenty-six (1926) feet.
