WHEREAS, on July 18, 1988, the Union County Court received a petition to vacate a portion of County Road #129A Starr Road, Union County, Oregon described as follows:

A portion of County Road No. 129A, being 30 feet on each side of the centerline of said County Road. With reference to County Survey No. 12-74 the centerline is described as follows:

Beginning at engineer's station 26+ 74.6 of said County Road No. 129A, said station being N 14°00'10" W a distance of 2724.42 feet from the southeast corner of Section 9 of Twp 2S, Range 38 EWM.

Thence S 89°56' W along the centerline of said road 658.20 feet to engineer's station 33+ 32.8 which station is on the west line of the NE 1/4 SE 1/4 of said Section 9 Twp 2S, Range 38 EWM.

WHEREAS, as required in ORS 368.346 the County Court directed the Union County Public Works Director to submit a report concerning the vacation request; and

WHEREAS, a report from the Union County Public Works Director was submitting recommending that the vacation not be granted based upon the need of the right-of-way for future residential expansion in the area; and

WHEREAS, the Union County Court held a public hearing on August 24, 1988, to receive testimony on the proposed vacation; and

WHEREAS, written testimony was received at the hearing illustrating the possible future need for the right-of-way for a through road to provide access to property legally dividable under Union County Land Use Plan and Union County Zoning, Partition and Subdivision Ordinance.
