WHEREAS, Union County received an application on November 18, 2003, requesting a roadway to be named Lyon Road;

WHEREAS, Union County Ordinance No. 1988-3 Section 1.200 requires the County Board of Commissioners to provide public hearing notice to adjoining landowners and in the newspaper;

WHEREAS, landowners adjacent to the affected roadway were mailed public hearing notice;

WHEREAS, The Observer newspaper published notice for a December 17, 2003 Board of Commissioners public hearing;

WHEREAS, oral and written testimony was received opposing naming the roadway Lyon Road and supporting the name Evers Canyon Road.

NOW THEREFORE, BE IT ORDAINED BY THE UNION COUNTY BOARD OF COMMISSIONERS, STATE OF OREGON:

SECTION 1: ROAD NAME ADOPTION

Evers Canyon Road is a private road with a 30 foot wide easement located on property described as Twp. 2N, Range 39 EWM, Section 36, Tax Lot 8300 providing access to property owned by Dewitt, Hardy & Evers described as Twp. 2N, Range 39 EWM, Tax Lot 8100; more particularly described as a private roadway as it now exists extending northwesterly from Parsons Lane, a County Road in Twp. 2N, Range 39 EWM, southeast quarter of the southeast quarter of Section 36, about one half mile to the most southerly line of the above mentioned Tax Lot 8100.

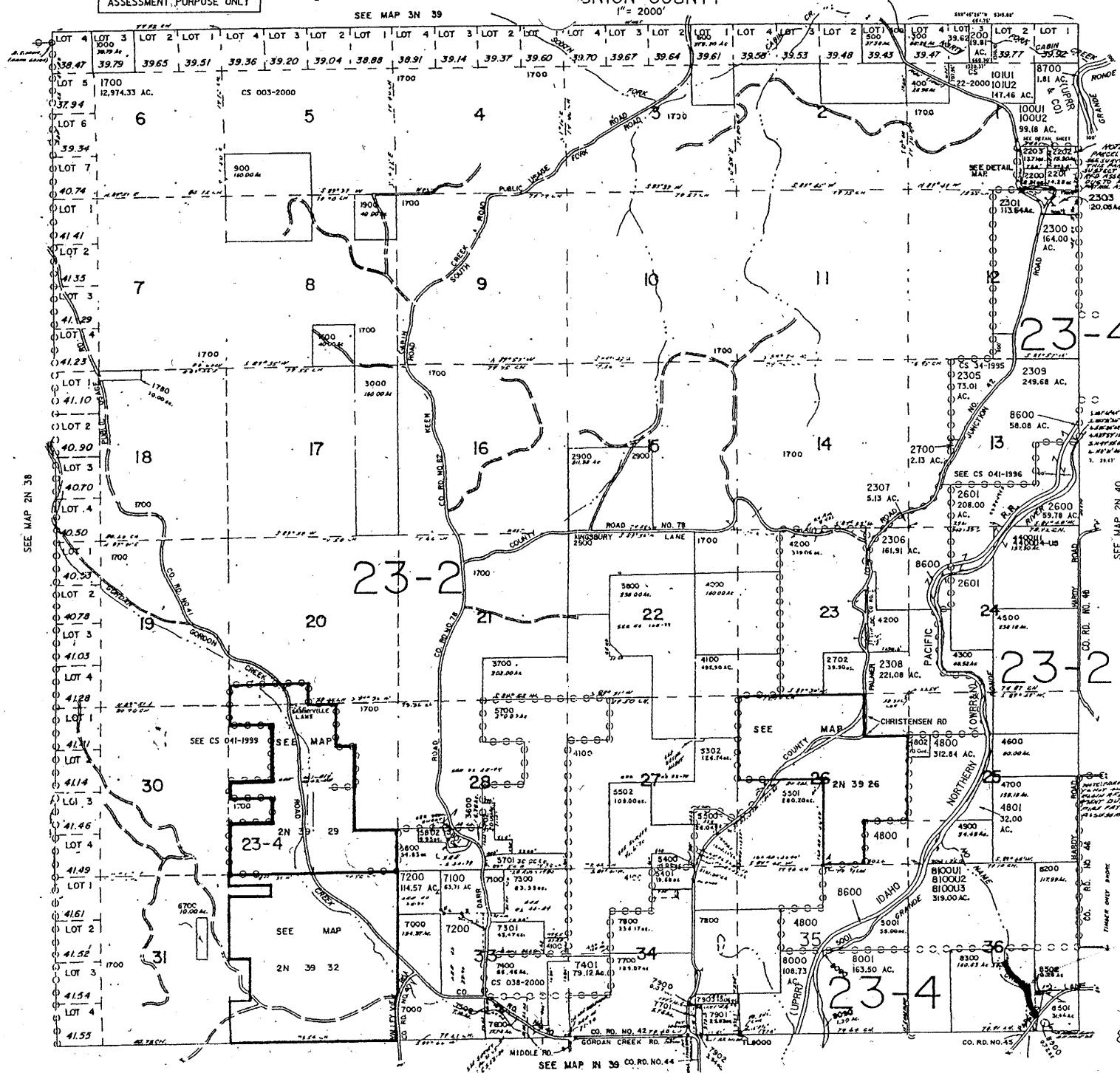
