WHEREAS, ORS 373.270 states that jurisdiction over a county road within a city may be transferred whenever the county governing body deems it necessary, expedient or for the best interest of the county to surrender jurisdiction over any county road or portion thereof within the corporate limits of any city and the governing body of the city deems it necessary or expedient and for the best interests of the city to acquire jurisdiction over the county road or part thereof to the same extent as it has over other public streets and alleys of the city;

WHEREAS, the County Board of Commissioners advertised in accordance to ORS 373.270 (2)(b) and held a public hearing on January 31, 2006 to accept public testimony regarding transferring the following county road segments: To Island City- all of Walton Road, McAlister Road (north from Buchanan Lane to Ore. Hwy 82) and North McAlister Road (north from Ore. Hwy 82 to Fruitdale Lane) and Buchanan Lane (from east Philynda Loop west to La Grande city limits). Also that portion of Mulholland Drive from Island City city limits east to Walton Road. To La Grande- Buchanan Lane (from the La Grande city limits west to the I-84 overpass) and that part of Mulholland Drive from Island City city limits west to 26th Street;

WHEREAS, the City of Island City formally accepted Union County's offer to transfer jurisdiction of the above road segments at their February 13, 2006 City Council meeting and the City of La Grande formally accepted Union County's offer by adopting Resolution Number 4480, Series 2006.

NOW THEREFORE, BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF THE COUNTY OF UNION, STATE OF OREGON:

SECTION 1: SURRENDER OF JURISDICTION

The jurisdiction of the following county road segments are surrendered to the cities of Island City and La Grande (see attached map):

To Island City- all of Walton Road, McAlister Road (north from Buchanan Lane to Ore. Hwy. 82) and North McAlister Road (north from Ore. Hwy 82 to Fruitdale Lane) and Buchanan Lane (from east Philynda Loop west to La Grande city limits). Also that portion of Mulholland Drive from Island City city limits east to Walton Road. To La Grande- Buchanan Lane (from the La Grande city limits west to the I-84 overpass) and that part of Mulholland Drive from Island City city limits west to 26th Street.
