WHEREAS, ORS 373.270 states that jurisdiction over a county road within a city may be transferred whenever the county governing body deems it necessary, expedient or for the best interest of the county to surrender jurisdiction over any county road or portion thereof within the corporate limits of any city and the governing body of the city deems it necessary or expedient and for the best interests of the city to acquire jurisdiction over the county road or part thereof to the same extent as it has over other public streets and alleys of the city;

WHEREAS, the following county road segment is proposed to be transferred: any part of South 12<sup>th</sup> Street in County Road jurisdiction beginning at its intersection with Gekeler Lane extending south to a point 130 feet north of the center of right-of-way intersection with Lakeview Lane.

WHEREAS, the County Board of Commissioners advertised in accordance to ORS 373.270 (2)(b) and held a public hearing to accept public testimony on the proposed jurisdiction transfer.

NOW THEREFORE, BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF THE COUNTY OF UNION, STATE OF OREGON:


SECTION 1: SURRENDER OF JURISDICTION OFFER



SECTION 2: TIME LIMIT OF ACCEPTANCE

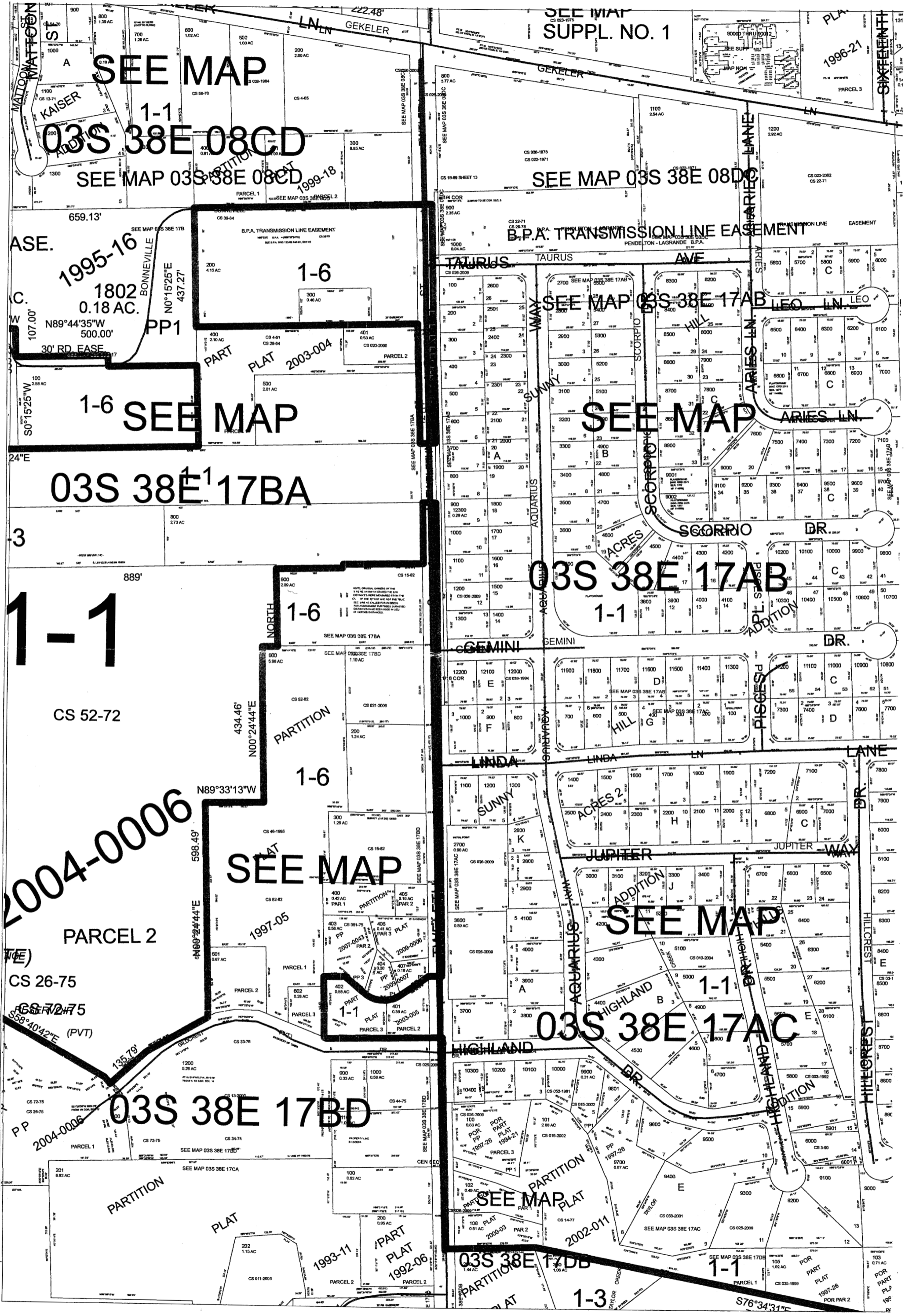
