WHEREAS, the Summerville Cemetery Maintenance District, in order to create additional burial lots, submitted a petition to vacate the following:

"O" Street as dedicated by the plat of Summerville Cemetery, within Blocks 7 & 8, as platted being "O" Street from the North line of Block 7 to the South line of Block 7 and "O" Street from the North line of Block 8 to the South line of Lots 40 and 41 of said Block 8 and a portion of Center Street as shown, and the alleyways within Block 7, between Lots 15 & 42, Lots 43 and 70, Lots 71 and 98, and in Block 8 of said cemetery, the alleyway between Lots 15 & 41.

WHEREAS, the Board of Commissioners advertised and held a public hearing on May 6, 2015 to accept testimony, deliberate and potentially make a decision.

NOW THEREFORE, BE IT ORDAINED BY THE UNION COUNTY BOARD OF COMMISSIONERS, STATE OF OREGON:

SECTION 1: STREET VACATION

The following street segment shown in the attached map (Exhibit A) is vacated to the adjacent properties per ORS 368.366 (1) (d):

"O" Street as dedicated by the plat of Summerville Cemetery, within Blocks 7 & 8, as platted being "O" Street from the North line of Block 7 to the South line of Block 7 and "O" Street from the North line of Block 8 to the South line of Lots 40 and 41 of said Block 8 and a portion of Center Street as shown, and the alleyways within Block 7, between Lots 15 & 42, Lots 43 and 70, Lots 71 and 98, and in Block 8 of said cemetery, the alleyway between Lots 15 & 41.


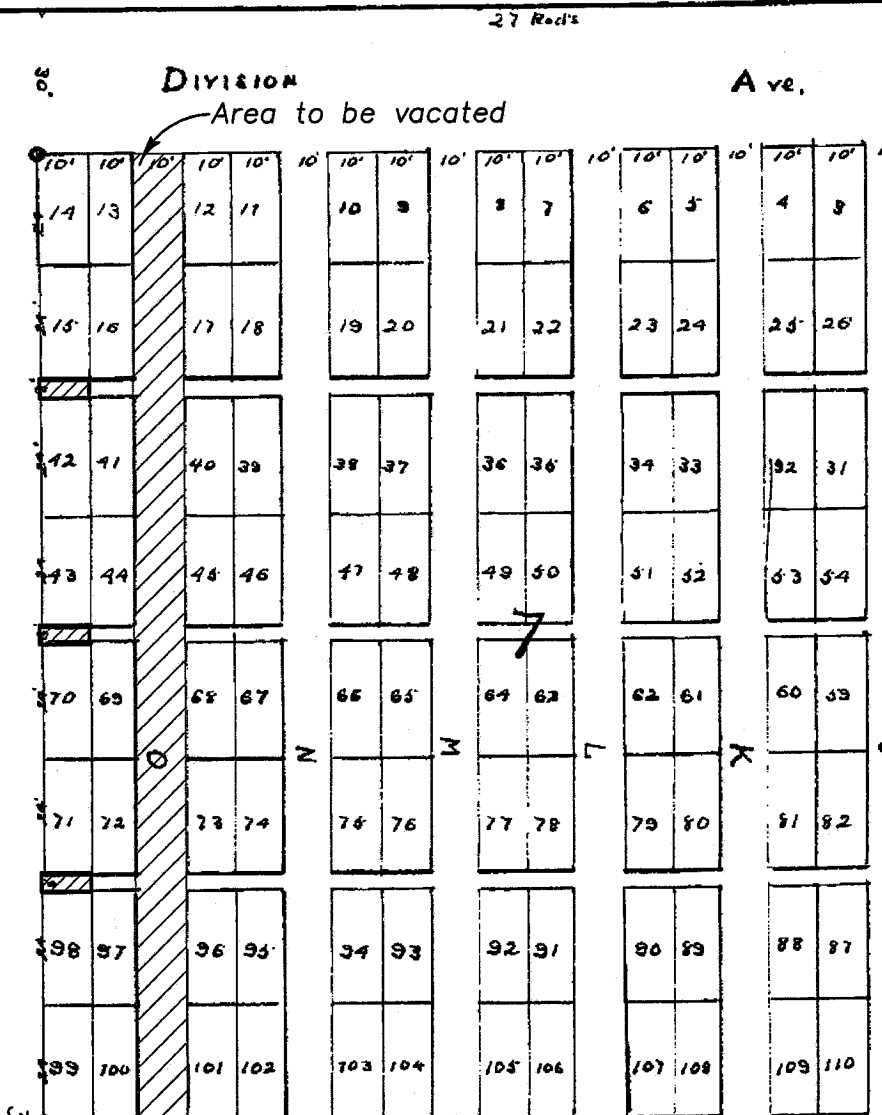
