## FINDINGS OF FACT

The County Court finds that the said Public Use roads are burdensome to maintain, are not needed as public use roads, have not been used as public use roads for many years, do not provide access to any property which is not already served by a County Road, and these roads in Alicel Orchard Tracts are a completely isolated part of any public roadway.

The Court further finds that no person or persons residing on the properties adjoining these roads and depending thereon for access will be adversely affected by their vacation and closure.

## ORDER

IT IS HEREBY ORDERED that the two remaining roads of Alicel Orchard Tracts (1) road lying between Tracts 7 and 18 and (2) road lying between Tracts 19 and 30 in Section 8, Township 2 South, Range 39 East of the Williamette Meridian be vacated pursuant to the maps attached hereto and marked Exhibits #1 and #2.
