WHEREAS, the Union County Court, meeting in special session on August 19, 1981, did hold a public hearing to consider the recommendation of the Union County Planning Commission to approve application for conditional use to establish a non-farm related dwelling as a second residence on property legally described as Township 2 South, Range 38 East of the Willamette Meridian, Section 33, Tax Lot 2800 and 2802.

FINDINGS OF FACT

- 1. The temporary establishment of a non-farm dwelling would not be in conflict with the limited farm use on the applicant's property.
- 2. The temporary dwelling would not seriously interfere with adjacent lands devoted to farm use because most adjacent parcels are similar in nature to the applicant's.
- 3. Tax Lot 2200 currently contains two (2) dwellings; therefore, the application is proposing a similar land use pattern as found in the area.

ALSO, the following CONDITIONS are placed on this approval:

Each twenty-four (@\$) months a letter is to be filed with the Planning Commission documenting the residency of Mrs. Harrington. In the event of the property being transferred or sold, the mobile home shall be removed. The second dwelling is to exist only during the longevity of the proposed occupant, Mrs. Harrington.

THEREFORE, it is hereby resolved that the members of the Union County Court being fully informed do hereby UPHOLD the decision of the Union County Planning Commission and HEREBY APPROVE the conditional use request of Mr. Hensley.
