And it appearing to the Court that each of said petitioners is unable to perform manual labor sufficient to earn a livlihood, and are, in some instances, sick, that they have no friends or relatives who are able or willing to render them any assistance; that they are in destitue circumstances and in need of aid,

And it further appearing to the Court that it would be just and equitable to make an allowance out of the General Fund of the County to each of said applicants for their immediate relief;

It is therefore considered and ordered by the Court that the Clerk of this Court issue a warrant issue a warrant upon the General Fund of the County in favor of each of the following named applicants, and for the amount set opposite each of the respective names, as follows, to-wit:-

In the matter of the vacation of a certain County road near Perry, Oregon.

It appearing to the Court from the report of the County Surveyor, that a certain part of the County Road in Union County, Oregon, near Perry, described as follows: commencing at a point 3.40 chains south of the quarter section corner between sections 35 and 35, Tp. 2 S. R. 37 E.W.M., thence south 66° 30' East 3.50 chains; thence south 76° E. 7.15 chains to the line of a present County road, is very danger9 ously located and contiguous to the line of a railroad operated by the Oregon Railway and Navigation Company, and that the public is in danger of suffering damages from the liklihood of accidents at said point.

And it further appearing to the Court that the Grande Ronde Lumber Company a is the owner of the premises over which said County road so described is situate, and said for the purpose of altering said County road the Grande Lumber Company has by a deed

duly executed and delivered and conveyed to the County a strip of land 30 feet on either side of a line described as follows, to-wit: commencing at a point 3.40 chains south of the quarter section corner between sections 34 and 35, Tp. 2 S. Renge 37 E. W. M.; thence south 66° 30' E. 3.15 chains; thence south 76° E. 7.15 chains, to a present County road, for road purposes; and the same having been placed in repair and condition for public travel, and the County Surveyor having surveyed and properly plated the said road, and reported the same to this Court.

Therefore, it is hereby ordered by the Court that the deed and grant from the said Grande Ronde Lumber Company be, and the same is hereby accepted, and the County Clerk of this County is ordered to record in the proper books kept for that purpose, the said report and plat the same upon the book of plats of County roads.

It is further ordered that all that portion of County road described as follows: commencing at a point 3.40 chains south of the quarter section corner between sections 34 and 35, Tp. 2 S., Range 37 E.W.M.; thence south 76°30' E. 3 chains; thence north 77°E. 5 chains; thence south 81°E 3.50 chains, to the line of a present County road, be, and the same is hereby vacated, and the jurisdiction of the County and the public therein surrendered.

In the matter of the petition of various residents and others for repairs of bridges and grading of roads in Dist. # 27.
