and not increasing the grade any. The damages to Mr. Sommer property would in my estimation be Twelve Hundred and Fifty Dollars (\$1250.00) along the line as petitioned for.

And the part to be vacated as petitioned for should not be vacated until they have some better route. If there was no road upon this part and I was sent as one of the Board to view, I would report unfavorable to it, as it climbs the hill to go down again.
