Comes now M.L. Carter, one of the petitioners for the above named proposed County road, and presents to the court the petition of himself and others, praying for the location and establishment of a county road, described as follows, to-wit:

Beginning at the southeast cor. of the west $\frac{1}{2}$ of the northwest $\frac{1}{4}$ of Sec. 2, Twp. 3 S. of Range 39 E.W.M., running thence north $\frac{1}{2}$ mi. to the northwest cor. of the west $\frac{1}{2}$ of the northwest $\frac{1}{4}$ Sec. 2 Twp. 3 South R. 39, there terminating. Vacating road beginning at the south east cor. of the northwest $\frac{1}{4}$ of Sec. 2, Twp. 3 R. 39 running thence north $\frac{1}{2}$ mi. to the northwest $\frac{1}{4}$ of same section, thence west $\frac{1}{4}$ mi. to the terminating point of road petitioned for.

And it appearing to the court that said petition is signed by more than twelve free-holders of this county, residing in the road district where the hereinbefore road is proposed to be, and that said petition properly specifies the place of beginning, intermediate points and place of termination of said road, and it satisfactorily appearing to the court that notice has been given by advertisement posted at the place of holding county court, to-wit: at the Court House, in the City of La Grande, County of Union, State of Oregon, and also in three public places in the vicinity of said proposed road, to-wit: one at the southwest corner of the east half of northwest quarter Sec. 2, also northwest corner of the east half of northwest quarter Sec. 2, also northwest corner of the east half of northwest quarter Sec. 2, Township 3 south Range 39 East Willamette Meridian, being beginning and terminal points of proposed road, one at S.W. cor. of NEt of Sec. 5, Twp. 3 S. of Range 39 E.W.M. being at cross roads of Peach & Cove roads, for more than thirty days immediately prior to the presentation of said petition to this court, notifying all persons concerned that application would be made to this court, at the present session of this court, and that the notices so posted were in due form and duly signed by the petitioners and that a bond for the cost of this proceeding has been duly given.

It is therefore ORDERED that L.D.Howland, County Surveyor and J.W. Sills and R.H.Davis constituting the Board of County Road Viewers, be and they are hereby directed to meet at the home of M.L.Carter on the 10th day of December, 1915, at the hour of 10 o'cbck A.M. or within five days thereafter and proceed to survey, view and lay out said road according to law.

Thereupon it was ORDERED that court be now adjourned until Thursday, December 16th, 1915, at 10 o'clock A.M.

In the matter of designating Official County Newspapers for the year 1916.

Now at this time this matter came on for hearing upon the application of the Weekly Observer-Star, and the Elgin Recorder to be designated as the official county newspapers of Union County for the year 1916, and it appearing to the court that both of said papers are of general circulation throughout the county and state, and it appearing that there is no contest in said matter.

It is therefore CONSIDERED and ORDERED that the La Grande Weekly Observer-Star and the Elgin Recorder be and they are hereby each designated as and for the official county newspapers of Union County.

In the matter of the epplication of J.F. O'Bryant for warehouse license.

Now at this time this matter came on for hearing upon the application of J.F.O'Bryant for werehouse license within the county of Union, and it appearing to the court that the said applicant has given a good and sufficient undertaking in the sum of \$2500.00, conditioned upon his faithful compliance with the laws of the State of Oregon, regulating the operation of warehouses,

It is therefore CONSIDERED and ORDERED that said bond be approved, and the Clerk of this court is hereby authorized and directed to issue to said J.F.O'Bryant a warehousemen's license in the manner provided by law.

In the matter of the appointment of an Agricultural Board.
