Comes now G. S. Long one of the petitioners for the above named proposed county road, and presents to the court the petition of himself and others, praying for the location and establishment of a county road, described as follows, to-wit: Beginning at county road No. 412 at the NE corner of the SE' of the SW of Sec. 35, Tp. 3 N.R. 39 E.W.M., thence west along the north line of the S' SW Sec. 35, and the north line of the SE' SE' Sec. 34, Tp. 3 N.R. 39 E.W.M. to the NW corner of said SE' SE' Sec. 34, thence south along the west line of said SE' SE' Sec. 34, Tp. 3 N.R. 39 and the west line and to the SW corner of Lot 1, Sec. 3 Tp. 2 N.R. 39 E.W.M., thence in a general southwesterly direction by the most practicable route to the north terminus of Road No. 496 in the SW of Sec. 9, Tp. 2 N.R. 39 End there to terminate.

And it appearing to the Court that said petition is signed by more than twelve free-holders of this county, residing in the road district where the hereinbefore described road is proposed to be, and that said petition properly specifies the place of beginning, intermediate points and place of termination of said road, and it satisfactorily appearing to the court that notice has been given by advertisement posted at the place of holding County Court to-wit: at the Court House in the city of La Grande, Union County, Oregon, and also in three public places in the vicinity of said proposed road, to-wit: on a fence at the NE corner of SE' SW' Sec. 35, Fp. 3 N.R. 39, the beginning of said road, one on a fence at the SW corner of Lot 1 Sec. 3 Tp. 2 N.R. 39, and one on a fence at the north terminus of road No. 496 in the SW' of Sec. 9, Tp. 2 N.R. 39, the end of said Road, for more than thirty days immediately prior to the presentation of said petition tothis court, notifying all persons concerned that application would be made to this court, at the present session of this court, and that the notices so posted were in due form and duly signed by the petitioners, and that a bond for the cost of this proceeding has been duly given.

It is therefore ORDERED that R. R. Neal, Deputy County Surveyor, and John M. Darr and B. F. Horrell constituting the Board of County Road Viewers, be, and they are hereby directed to meet at J.M.Darr residence on the 17th day of September, 1917, at the hour of 10 o'clock A.M., or within five days thereafter and proceed to survey, view and lay out said road according to law.
