hands of the County Treasurer amounting to the sum of \$1072.65 be, and the same is, hereby appropriated to the Elgin Fair Association to be used in paying premiums and the County Treasurer is hereby authorized and directed to turn the said funds over to the Treasurer of the Elgin Fair Association.

In the matter of filling vacancies on the various Election Boards.

Now at this time it appearing to the Court that Grant Sturtevant, who has been acting Judge of Election in La Grande Precinct No. 5, has removed from said precinct and is no longer qualified to act as a member of said election board,

It is ORDERED that Francis Carbine be and he is hereby appointed as Judge of Election for La Grande Precinct No. 5 to serve as such until January 1st, 1924.

In the matter of the opening of Ballot Boxes.

Now at this time, upon application of the County Clerk, it is ORDERED that said Clerk be and he is hereby authorized and directed to open the ballot boxes and burn the ballots and stubs remaining therein from the last election and to prepare said boxes for use at the Special Election to be held November 6th, 1923.

In the matter of designating Polling Places for use at the Special Election to be held November 6th, 1923.

Now at this time it is ORDERED that the polling places used at the last election which was held on November 7th, 1922 be, and the same are, hereby designated as the polling places to be used for the Special Election to be held on November 6th, 1923.

In the matter of the vacation of certain Streets and Roads in Williamson's Addition to La Grande, Union County, Oregon.

Now at this time this matter came on for hearing upon the petition of the Mount Emily Timber Company, the Union Box Company and the Oregon-Washington Railroad & Navigation Company, for the vacation of the streets and roads hereinafter described, and it appearing to the County Court of Union County, Oregon, that the said petitioners are the owners of all the land bounding and abutting upon the streets to be vacated, and that such streets are within the plats filed with the Recorder of Conveyances of Union County, Oregon, and that there is no objection to the closing of said streets, and that for the proper use of the lands in question it is necessary that said streets and roads be vacated, and the court being fully advised in the premises,

It is hereby CONSIDERED and ORDERED:

That all that part of "Q" Avenue, beginning at the East line of the alley which runs through Blocks 16 and 25 of Williamson's Addition to La Grande, Union County, Oregon, and extending Easterly to the right of way of the Oregon-Washington Railroad & Navigation Company, be and the same is hereby vacated;

That all that part of "R" Avenue lying between the East half of Block 15 and the East half of Block 16, Williamson's Addition to La Grande, Union County, Oregon, be and the same is hereby vacated;

THURSDAY, OCTOBER 4th, 1923.

That all that part of "S" Avenue lying between the East half of Block 6 and the East half of Block 15 of Williamson's Addition to La Grande, Union County, Oregon, be and the same is hereby vacated;

That all that part of "T" Avenue, beginning at the East boundary line of North Maple Street and extending in an Easterly direction to the East Boundary line of the right of way of the spur track of the Oregon-Washington Railroad & Navigation Company, sometimes known as the Sugar Spur, in La Grande, Oregon, be and the same is hereby vacated;

That all that part of North Maple Street, beginning at the South line of "T" Avenue and extending Southerly to the right of way of the Oregon-Washington Railroad & Navigation Company, in La Grande, Oregon, be and the same is hereby vacated;

That all that part of North Cherry Street lying between Blocks 2 and 3 of Williamson's Addition to La Grande, Union County, Oregon, be and the same is hereby vacated

That all that part of North Balm Street lying between Blocks 1 and 2 of Williamson's Addition to La Grande, Union County, Oregon, be and the same is hereby vacated

That all that part of Pine Street lying between Blocks 3 and 4 of Williamson's Addition to La Grande, Union County, Oregon, be and the same is hereby vacated;

That all that part of an unnamed street lying between Block 1 of Williamson's Addition to La Grande, Union County, Oregon, and Lots 13 and 14 of Block 7, Pleasant Home Addition to La Grande, Union County, Oregon, be and the same is hereby vacated.

In the matter of making final payment on the Courthouse property.

Now at this time, it appearing to the Court that the County has sufficient funds on hand with which to make the final payment upon the contract with the City of La Grande for the purchase of the Courthouse property,

It is CONSIDERED AND ORDERED that the County Clerk be and he is hereby authorized and directed to arrange with the city of La Grande if possible for the making of the final payment on said contract at the November meeting of this Court.

. Thereupon the Journal of today's proceedings was read, approved, and is here now signed, and it was ORDERED that Court be now adjourned for the term.
