In the matter of vacating a portion of Gangloff Second Addition to the City of La Grande, Union County, Oregon.

Whereas, Mary T. Foley, the owner in fee-simple of tracts A, B, C, D, E, F, G, H, I, J, K, L and M, and the Streets and alleys abutting thereon, in Gangloff Second Addition to the city of La Grande, Union County, Oregon, has made and caused to be filed in this Court her petition for the vacating of said tracts and the streets and alleys abutting therein, and

It appearing to the Court that the said streets and alleys are not now valuable, nor are they needed by the public and that after being vacated they would be immediately re-plated; that it is the purpose of the said Mary T. Foley to re-dedicate the said land as "Foley Addition to the city of La Grande, Union County, Oregon"; that it is the chief purpose of this vacation and me-dedication to correct errors in the original dedication; that there are no person nor persons whose right would be effected, injured or damaged by the vacation of said tracts, or the streets, avenues or alleys abutting thereon; that none of said streets, avenues or alleys, nor any part thereof, have ever been opened or improved or in general use of the public, nor are they needed for public use or occupancy; that the said tracts are without the corporate limits of the said city of La Grande, Union County, Oregon; that the said Mary T. Foley has, in compliance with the statute, caused written notice of the said petition, containing a description of the property to be vacated, to be posted in three of the most public places in the vicinity of said property, to-wit: At the Court House, City Hall and Post Office in the city of La Grande, Union County, Oregon, for more than 30 days prior hereto; that there has been no opposition to said petition, nor no objection thereto, filed in this Court, THEREFORE

It is the order of the County Court of Union County, Oregon, in regular session convened that tracts A, B, C, D, E, F, G, H, I, J, K, L and M in Gangloff Second Addition to the City of La Grande, Union County, Oregon, and the streets and alleys abutting thereon, be, and they hereby are, vacated and that the portion of the plat containing said tracts be, and it hereby is cancelled.

In the matter of the approval of the Plat of Gangloff Addition to Romig's Addition to the City of La Grande, Oregon.

Now at this time is presented to the Court for approval the plat of Gangloff Addition to Romig's Addition to the City of La Grande, Oregon, and it appearing to the Court that said plat is regular and bears the certificate of the County Surveyor and County Assessor as required by law,

It is therefore ORDERED that said plat be and the same is hereby approved and that it be recorded in the record of plats of Union County, Oregon.

In the matter of the application of Soren Larson for County Aid.

Now at this time, it is ORDERED that the above entitled matter be and the same is hereby continued for the term.

In the matter of the appointment of a Constable for the North Powder Constable District.

Now at this time, it appearing to the Court that a vacancy exists in the office of Constable in the North Powder District and it further appearing that E. P. Ashby, a competent and qualified man for said position, has applied for said appointment,

It is therefore CONSIDERED AND ORDERED that said E. P. Ashby be and he is hereby appointed as Constable of the North Powder District to fill the unexpired term of said office or until his successor is elected and qualified, and that he enter upon his duties upon his taking the oath of office and filing an approved undertaking as required by law.
