Court met pursuant to adjournment.

Present: Same officers as on last Judicial Day.

Due proclamation of the opening of Court having been made, the Journal of the last day's proceedings was read, approved, and is here now signed.

Whereupon the following proceedings were had, to-wit:

In the matter of the claim of Fred Self for indemnity for diseased cow slaughtered under the provisions of Chapter 435, Laws of 1927,

Now at this time is presented to the Court the claim of Fred Self for Indemnity in the sum of \$10.00 for one cow over 1 year old, slaughtered under the provisions of Chapter 435, Laws of 1927, and it appearing to the Court from the certificate of H. C. Fullington, the Veterinarian supervising the slaughter of said animal, that said animal was killed on July 31, 1938, at Seattle, Washington, and from the affidavit of Fred Self, the claimant, that said animal was owned in the State the required length of time to come under the provisions of Chapter 435, Laws of 1927, and it further appearing that the requirements relative to the disinfection of the stables where said animal was kept have been complied with, and no one having appeared to resist said claim,

It is CONSIDERED AND ORDERED that the same be and is hereby allowed in the sum of \$10.00 and the County Clerk is hereby authorized and directed to draw a warrant on the General Fund of the County in favor of Fred Self in the sum of \$5.00, said sum being one half of said claim and the amount to be paid by Union County.

In the matter of the application of Lottie M. Ford for Widow's Pension.

Now at this time, it appearing to the Court that the County Judge, acting as Juvenile Judge, has allowed the application of Lottie M. Ford for widow's pension in the sum of \$20.00 per month,

It is THEREFORE CONSIDERED AND ORDERED that said allowance made by the County Judge be and the same is hereby approved.

In the matter of the vacation of of portion of County Road No. 563.

WHEREAS, it appears to the County Court of Union County, Oregon, that a portion of County Road No. 563, more particularly described as follows: Beginning at a point 800 feet north and 1320 feet west of the section corner common to sections 20, 21, 28 & 29 T 5 S, R 39 EWM, thence south 2,120 feet to angle 2 as described in the original notes; thence east 1320 feet to angle 3; thence south 7,741.8 feet to angle 4; thence south 34 west a distance of 396 feet to angle 5; thence south 2 west 396 feet to angle 6; thence south 35 east 409 feet to angle 7 at the terminus of the proposed road vacation. Said point being approximately 280 feet north of the section corner common to sections 32 and 33 T 5 S, R 39 EWM and sections 4 and 5 T 6 S, R 39 EWM, has become useless as a part of the general road system of Union County as soon as the construction of the North Powder-

Clover Creek Market Road is completed, and is burdensome to maintain, and

WHEREAS, the Public is served by a better road in the same vicinity as that portion of said road proposed to be vacated, and will not be inconvenienced by said vacation,

Therefore BE IT RESOLVED that such proceedings as are required by law be taken to vacate that portion of Road No. 563 as above described.

In the matter of the application of Pleasant Grove Grange No. 475 for a Dance Hall Permit.

Now at this time is presented to the Court the petition of Pleasant Grove Grange No. 475 for a license to conduct a Dance Hall at Summerville, and it appearing to the Court that said application is in due form and signed by 12 freeholders residing in the School District in which the dance hall is located and it further appearing to the Court that the applicant has filed a good and sufficient bond as required by law in the sum of \$500.00, and it further appearing to the Court that the applicant will run an orderly house,

It is CONSIDERED AND ORDERED that the County Clerk be and he is hereby authorized and directed to issue a Dance Hall License to the said Pleasant Grove Grange No. 475 upon payment of the fee required by law.

In the matter of the monthly report of the County Treasurer and credits given her.

Comes now Florence Bacon, Treasurer of Union County, Oregon, and presents to the Court certain vouchers, warrants, and receipts showing that she has paid out of the various funds of the County certain sums of money. And it appearing to the Court from an examination of said vouchers and warrants that the sums have been duly paid out of the funds applicable thereto, that the warrants were regularly issued on the order of the Court, and that the Treasurer should have credit upon her account for the same,

It is therefore ORDERED that said vouchers, receipts, etc., be filed and the Treasurer be given credit therefor as follows:
