IN THE MATTER OF MAINTENANCE OF COUNTY ROAD 60 aka ROAD 535:

Now comes before the County Court for the County of Union, a request for the members of this Court to make clear to all considered residents in the area of County Road 60 aka Road 535, as to the ownership and distance of said road that will be maintained by the County of Union. The members of this Court having knowledge that said road was originally a wagon, road, then was improved by the CCC road crews from Highway 82 to the middle fork of Clarke Creek and thereafter to present date the County has improved said road only to thee turn-around which is approximately 690 feet southeasterly of the north line of the northeast quarter of the southeast quarter of Section 3, Township 1 South, Range 40 EWM.

Be it RESOLVED that the County of Union Road Department will hereafter continue to maintain only that portion of said road descreibed herein and will not maintain any other portions of Road 60 aka Road 535.
