WHEREAS a petition has been filed with the Union County Court requesting the above description of the County Road #115 be vacated for the reason that it has never been used as a part of the County Road System, dangerous and an unnecessary maintenance burden upon the County, and the public and the County would be benefitted by its vacation, and

WHEREAS, the County Court, on its own motion, in response to the petition filed herein, desires to vacate said portion of County Road number 115 as the same appears on the attached map marked Exhibit A, and

WHEREAS, the public would be benefitted by the vacation of the road,

BE IT RESOLVED that proceedings be instituted to vacate the portion of County Road #115 heretofore described as the same appears on the attached Exhibit A.

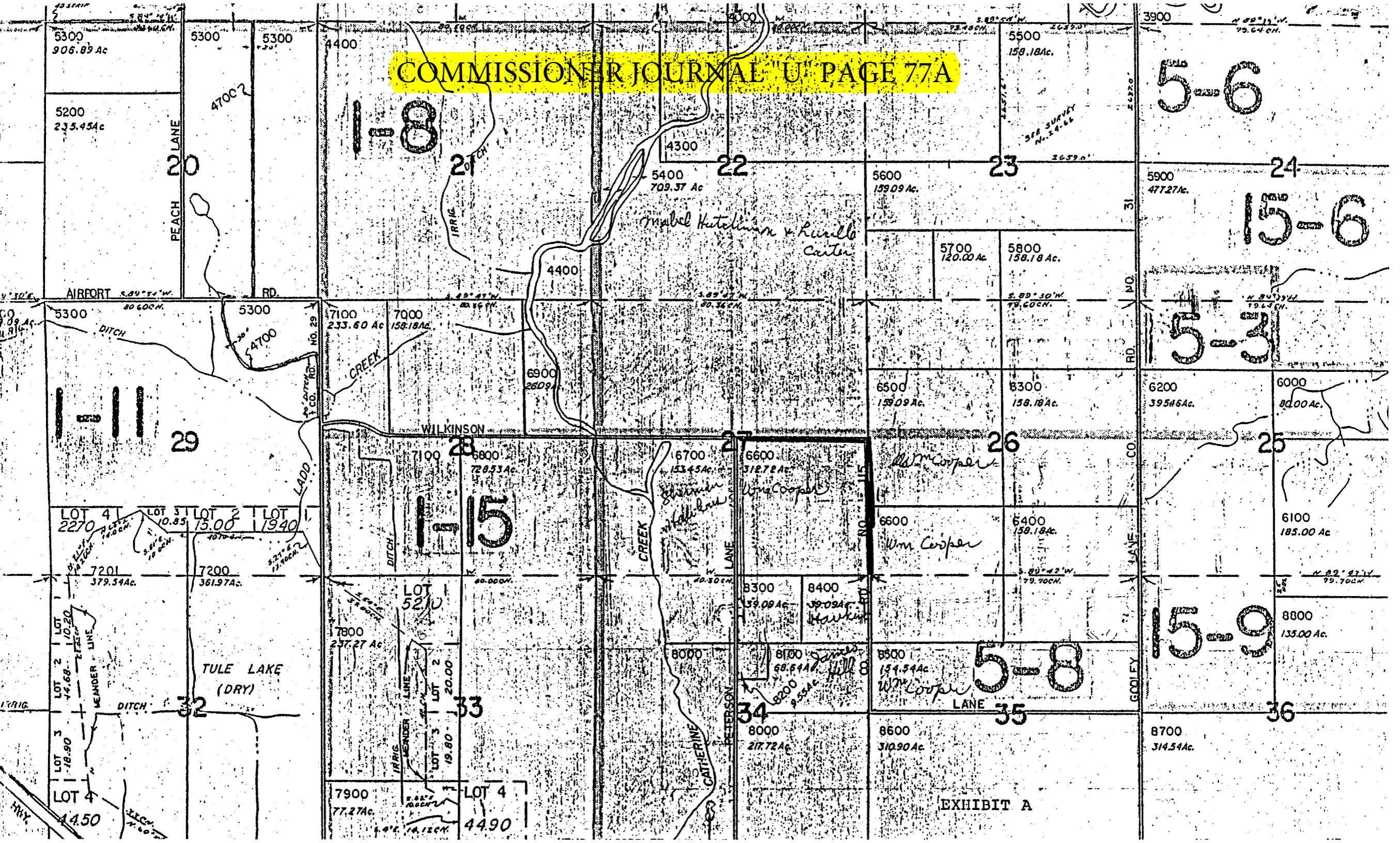

EXHIBIT A

IN THE MATTER OF THE VACATION OF
A PORTION OF COUNTY ROAD #115

PURSUANT TO a resolution by the County Court of Union County, Oregon, on the 12th day of January 1973, and in accordance with ORS 368.570 it is hereby

ORDERED that the County Roadmaster examine the portion of County Road #115, from the center of section 27, T3S, 39 EWM, thence east one-half mile, thence south one-half mile to the SE corner of Section 27, located in Union County, Oregon, as the same appears on the attached Exhibit A and make a report in writing on the road on or before February 1, 1973.

THIS REPORT shall include the opinion of the Roadmaster as to whether the road should be vacated whether the road is or has been in use as a part of the County Road System, whether it will be advisable to preserve the road as a part of the general road system in the future, or whether the public will be benefitted by the vacation of said County Road, and all other facts, matters and things which are of importance to the County Court.

Upon completion of the report, it shall be filed with the County Clerk.

IT IS FURTHER ORDERED that March 8, 1973 at 3:30 o'clock in the County Courtroom in the Courthouse in the City of La Grande, Oregon, be and the same hereby fixed as the time and place for hearing said report.

IT IS FURTHER ORDERED that the Sheriff of Union County, Oregon, or one of his deputies, is hereby ordered and directed to cause notice of the hearing to be given by advertisement posted at the place of holding County Court, the Union County Courthouse, and at three public places in the vicinity of the road, at least thirty days before the date set for hearing, and proof that the notice has been given shall be made by the Sheriff of Union County, Oregon or one of his deputies.

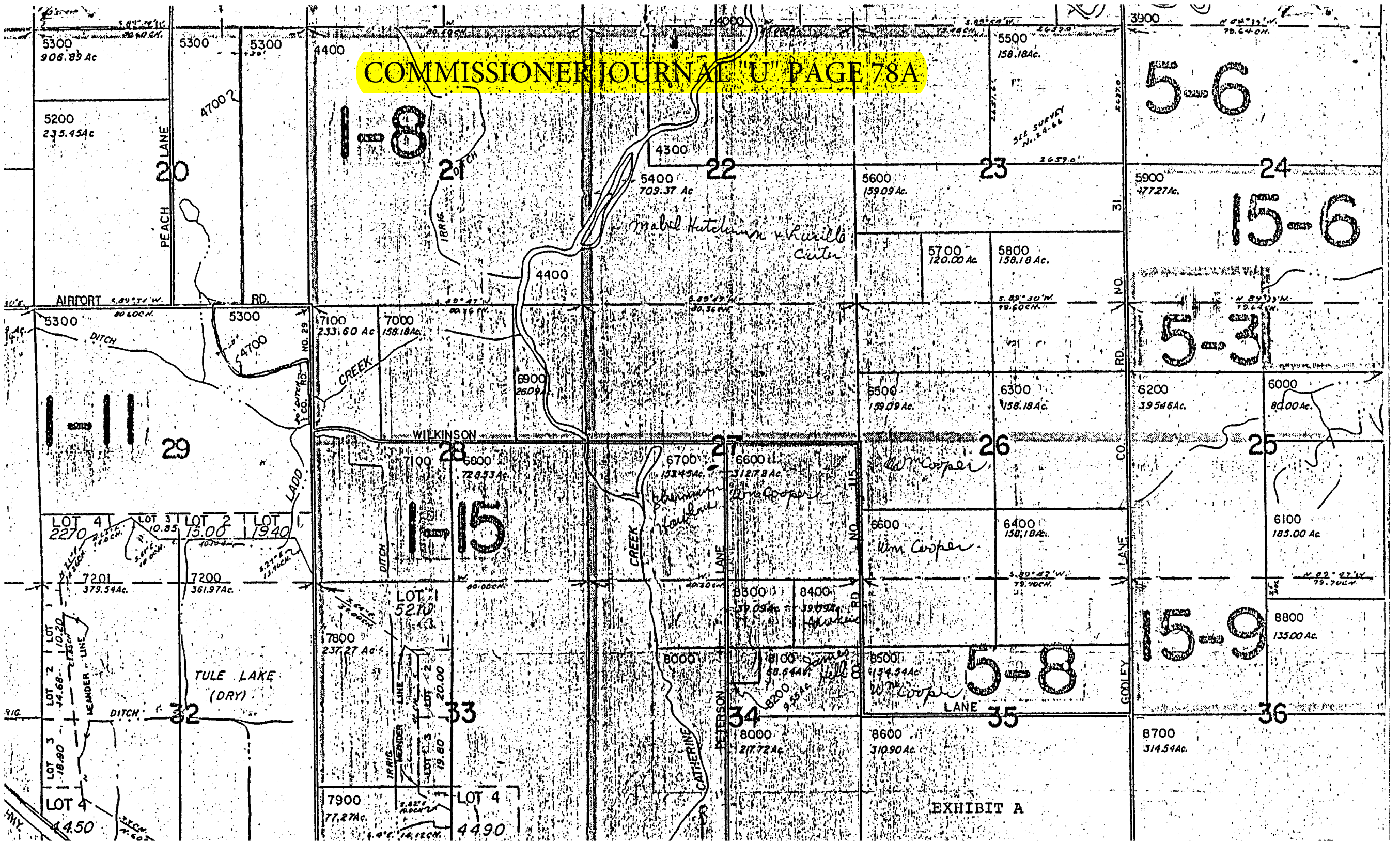

ORDER OF ROAD VACATION

On this day this matter came on for hearing and the Court in session pursuant to ORS 368.570 and ORS 368.580 did consider the matter of the vacation of that portion of Bond Lane located between relocated Old Oregon Trail Highway, Interstate 80 - N and the La Grande-Union Highway 203, as the same appears on the attached Exhibit A.

FINDING OF FACTS

The County Court finds that the said County road is burdensome to maintain, is not needed as a part of the County Road System, and has not been used as a part of the said County Road System for many years and further finds that since the relocation of the Old Oregon Trail Highway, this portion of Bond Lane is a completely isolated part of the County Road System.

The Court further finds that no person or persons residing on the County road and depending thereon for access will be adversely affected by its closure.

ORDER

IT IS HEREBY ORDERED that the portion of the Bond Lane located between relocated Old Oregon Trail Highway, Interstate 80-N and the La Grande-Union Highway 203 be vacated pursuant to the map attached hereto and marked Exhibit A
