IN THE MATTER OF) COURT ORDER A ZONE CHANGE)

WHEREAS, The Union County Planning Commission held a formal hearing April 23, 1973 at 7:40 P.M. in Room 218 of the Federal Building, La Grande, Oregon, for a proposed boundary line change that would cause the area inside the boundary to be residential and outside to be agricultural. A Motion was made to accept the new dividing line as a boundary between agricultural and residential and that zone change recommendation be taken to County Court.

WHEREAS, a public hearing before the County Court was held the 3rd day of May, 1973 at 4:00 o"clock P.M. to consider the zone change recommended by the Union County Planning Commission with a new proposed boundary between residential and agricultural zones as herein described; Beginning at the SE Corner of the NW % of Sec. 18, T 3S, R 38 E.W.M., thence North 2640 ft. to the NE corner of said NW%, thence North along the East boundary of the SW % of Sec. 7, T 3S, R 38 E.W.M. to the South Boundary of Modelaire addition to the City of La Grande; thence West to the West boundary of Modelaire addition; thence North to North boundary of Modelaire addition; thence East to the East boundary of said SW %; thence North to the NE Corner of said SW %; thence West 330 ft.; thence North 560 ft.; thence West 330 ft.; thence North 1320 ft.; thence North 990 ft.; thence North 660 ft. more or less to the NW Corner of the NE% of SW% of Sec. 6. T 3S, R 38 E.W.M.; thence North 330 ft.; thence West 330 ft.; thence North along the West boundary of said Sec. 6; thence North along the West boundary of Sec. 31, T 2S, R 38 E.W.M., to the South boundary of the Old Oregon Trail Highway U.S. No 30. The above description being the Westernboundary of the proposed county residential zone.

WHEREAS, no opposition was presented to the herein stated boundary change the County Court DOES HEREBY APPROVE the residential to agricultural zone change as recommended by the Union County Planning Commission upon the property as herein described.
