ORDER OF ROAD VACATION

On this day this matter came on for hearing and the Court in session pursuant to ORS 368.570 ans ORS 368.580 did consider the matter of the vacation of that portion of the streets and alleys located in Pratt's Subdivision, more particularly described as:

All of that portion of NOrth Portland Street lying North of the North boundary of "X" Avenue,

All of that portion of "Z" Avenue and all that portion of "Y" Avenue which lies Westerly of the West right of way line of Highway Inerstate 80 North and East of the East right of way line of North Portland Street;

All of the alleys through Blocks 2 and 3; located in Union County, Oregon, as the same appears on the attached Exhibit "A".

## FINDINGS OF FACT

The County Court finds that the said County road is burdensome to maintain, is not needed as a part of the County Road System, and has not been used as a part of said County Road System for many years and further finds that since the relocation of teh Old Oregon Trail Highway, Interstate 80N this portion of the streets and alleys above described are not an integral of the County Road System.

The Court further finds that no person or persons residing on the County road, streets, and depending theron for access will be adversely affected by closure.

## ORDER

IT IS HEREBY ORDERED that the portion of the streets fand alleys located in Pratt's Subdivision hereinabove described be vacated pursuant to the map attached marked Exhibit "A".
