COURT ORDER #79-158

WHEREAS, it appearing to the Union County Court setting in regular session on the 25th day of June, 1980, that Resolution #79-85 was inadvertantly executed and filed.

Resolution #79-86, filed the 16th day of January, 1980, instituted road vacation proceedings for a portion of Main Street and Foley Street. Oregon Revised Statute Chapter 368 sets forth the procedure for vacation of County roads and Resolution #79-85 was filed prior to or simultaneous with the Resolution instituting the road vacation proceedings and should new be voided as being improperly executed and filed.
