



### SURVEY NARRATIVE

THIS MINOR LAND PARTITION WAS PREPARED TO PROVIDE FOR THE ADJUSTMENT OF A COMMON BOUNDARY LINE BETWEEN TWO EXISTING PROPERTIES. THIS PARTITION WAS NOT SURVEYED IN THE FIELD. THE BOUNDARIES OF THE EXISTING PROPERTIES AND THE DESCRIPTIONS OF THE PARCELS I AND 2 HAVE BEEN PREPARED SOLELY WITH REFERENCE TO THE DOCUMENTS CITED IN REFERENCE MATERIAL. AREAS SHOWN ARE BASED ON COUNTY ASSESSMENT RECORDS.

#### SURVEYOR'S STATEMENT

I, GARY L. LANGLITZ, OREGON REGISTERED LAND SURVEYOR NO. 1099. DO HEREBY STATE THAT I HAVE PREPARED THIS MINOR LAND PARTITION IN ACCORDANCE WITH THE DESIRES OF THE PARTITIONER AND IN ACCORDANCE WITH OREGON REVISED STATUTES, AND THAT THE FOLLOWING DESCRIPTIONS ARE TRUE AND CORRECT AND ARE BASED ON EXISTING DOCUMENTS OF RECORD:



IN TOWNSHIP 3 SOUTH, RANGE 38 EAST OF THE WILLAMETTE MERIDIAN

SECTION 16: THAT PORTION OF THE EAST ONE-HALF OF NORTHWEST QUARTER AND THE WEST ONE-HALF OF NORTHEAST QUARTER DESCRIBED AS:

BEGINNING AT A POINT WHICH IS 1,389.25 FEET WEST OF THE NORTHEAST CORNER OF THE NORTHWEST QUARTER OF THE NORTHEAST QUARTER; THENCE SOUTH 477.54 FEET TO THE SOUTHWEST CORNER OF LAND CONVEYED TO TRINITY BAPTIST CHURCH OF LA GRANDE, OREGON (MICROFILM DOCUMENT NO. 90816, UNION COUNTY, OREGON), THENCE EAST ALONG THE SOUTH LINE OF SAID CHURCH PROPERTY 292 FEET TO A POINT WHICH IS 66.5 RODS WEST OF THE EAST LINE OF SAID NORTHWEST QUARTER OF NORTHEAST QUARTER; THENCE SOUTH PARALLEL WITH AND 66.5 RODS WEST OF THE EAST LINE OF SAID SUBDIVISION A DISTANCE OF 842.46 FEET, MORE OR LESS, TO THE SOUTH LINE OF SAID NORTHWEST QUARTER OF NORTHEAST QUARTER; THENCE WEST 618.75 FEET (37.5 RODS); THENCE NORTH PARALLEL WITH THE WEST LINE OF THE NORTHEAST QUARTER OF NORTHWEST QUARTER OF SAID SECTION A DISTANCE OF 1,320 FEET (80 RODS) TO THE NORTH LINE OF SAID NORTHEAST QUARTER OF NORTHWEST QUARTER; THENCE EAST 326.75 FEET TO THE POINT OF BEGINNING.
