

SURVEYOR'S CERTIFICATE

I, GARY LANGLITZ, OREGON LAND SURVEYOR NO. 1099, BEING DULY SWORN, DEPOSE AND SAY THAT I HAVE PREPARED THIS MAJOR LAND PARTITION AS DIRECTED BY THE OWNERS AND THAT I HAVE SURVEYED AND MONUMENTED SAID PARTITION AS SHOWN ON THE ANNEXED PLAT, THE FOLLOWING BEING A TRUE AND CORRECT DESCRIPTION OF SAID PARTITION:

A PARCEL OF LAND LOCATED IN THE SOUTHEAST ONE-OUARTER (1/4) OF SECTION 26 AND IN THE NORTHEAST ONE-OUARTER (1/4) OF SECTION 35, TOWNSHIP 2 SOUTH, RANGE 38 EAST OF THE WILLAMETTE MERIDIAN, UNION COUNTY, OREGON, SAID PARCEL BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

COMMENCING AT THE SOUTHEAST CORNER OF SAID SECTION 26; THENCE ALONG THE EAST LINE OF SAID SECTION 26, NO 08'28"W, 728.50 FEET TO A POINT ON THE SOUTHEASTERLY RIGHT-OF-WAY LINE OF UNION PACIFIC RAILROAD COMPANY;

THENCE ALONG SAID SOUTHEASTERLY RIGHT-OF-WAY LINE, \$58°47'20"W, 35.02 FEET TO THE NORTHEAST CORNER OF THAT CERTAIN PARCEL OF LAND CONVEYED BY UNION PACIFIC RAILROAD COMPANY TO LA GRANDE INDUSTRIAL DEVELOPMENT CORPORATION BY DEED DATED FEBRUARY 3, 1969, SAID POINT BEING 30.0 FEET DISTANT WESTERLY, MEASURED AT RIGHT ANGLES, FROM SAID EAST LINE OF SECTION 26;

THENCE PARALLEL WITH SAID EAST LINE AND ALONG THE EAST LINE OF SAID CONVEYED PARCEL, SO'08'28"E, 710.22 FEET TO A POINT ON THE SOUTH LINE OF SAID SECTION 26;

THENCE PARALLEL WITH THE EAST LINE OF SAID SECTION 35 AND CONTINUING ALONG THE EAST LINE OF SAID CONVEYED PARCEL SO"04'44"W, 329.53 FEET TO THE NORTHEAST CORNER OF THAT CERTAIN PARCEL OF LAND CONVEYED BY UNION PACIFIC LAND RESOURCES CORPORATION TO FLEETWOOD TRAVEL TRAILERS OF OREGON, INC., BY SPECIAL WARRANTY DEED DATED OCTOBER 12,

THENCE ALONG THE BOUNDARY OF SAID CONVEYED PARCEL, THE FOLLOWING THREE (3) COURSES:

- PARALLEL WITH THE EAST LINE OF SAID SECTION 35, SO'04'44"W, 570.25 FEET TO THE BEGINNING OF A CURVE, CONCAVE NORTHWESTERLY, TO WHICH POINT A RADIAL LINE BEARS \$89°55'16"E, 30.00 FEET;
- SOUTHWESTERLY, ALONG SAID CURVE, THROUGH A CENTRAL ANGLE OF 90°00'00", AN ARC DISTANCE OF 47.12 FEET;
- N89°55'16"W, 595.00 FEET TO THE SOUTHWEST CORNER OF SAID CONVEYED PARCEL AND THE TRUE POINT OF BEGINNING OF THIS DESCRIPTION;

THENCE CONTINUING FROM SAID TRUE POINT OF BEGINNING N89°55'16"W, 340.00 FEET TO THE BEGINNING OF A CURVE, CONCAVE NORTHEASTERLY, TO WHICH POINT A RADIAL LINE BEARS SO 04'44"W 30.00 FEET;

THENCE NORTHWESTERLY, ALONG SAID CURVE, THROUGH A CENTRAL ANGLE OF 90°00'00", AN ARC DISTANCE OF 47.12 FEET;

THENCE PARALLEL WITH THE WEST LINE AND WEST LINE EXTENDED OF SAID PARCEL OF LAND CONVEYED BY UNION PACIFIC LAND RESOURCES CORPORATION TO FLEETWOOD TRAVEL TRAILERS OF OREGON, INC., BY SPECIAL WARRANTY DEED DATED OCTOBER 12, 1987, NO°04'44"E 782.38 FEET TO THE BEGINNING OF A NON-TANGENT CIRCULAR CURVE;

THENCE 188.91 FEET ALONG THE ARC OF SAID CURVE, CONCAVE SOUTHWESTERLY, HAVING A RADIUS OF 70.00 FEET, THE LONG CHORD OF WHICH BEARS N12°36'35"W 136.58 FEET, TO A POINT ON THE WESTERLY BOUNDARY OF THAT PARCEL OF LAND CONVEYED TO ALLAN R. CHASE AND JIM BAUER BY UNION COUNTY MICROFILM DEED NO. 135504;

THENCE NOTO4'44"E 73.20 FEET ALONG SAID WESTERLY BOUNDARY TO THE SOUTHEASTERLY RIGHT-OF-WAY LINE OF THE JOSEPH BRANCH OF THE UNION PACIFIC RAILROAD COMPANY;

THENCE ALONG SAID SOUTHEASTERLY RIGHT-OF-WAY LINE N58°49'10"E TO THE NORTHWEST CORNER OF SAID PARCEL OF LAND CONVEYED BY UNION PACIFIC RAILROAD COMPANY TO LA GRANDE INDUSTRIAL DEVELOPMENT CORPORATION BY DEED DATED FEBRUARY 3, 1969, FROM WHICH SAID POINT SAID NORTHEAST CORNER OF SAID LA GRANDE PARCEL BEARS N58°47'20"E, 594.54 FEET;

THENCE ALONG THE WESTERLY BOUNDARY OF SAID PARCEL CONVEYED TO LA GRANDE INDUSTRIAL DEVELOPMENT CORPORATION, THE FOLLOWING THREE (3) COURSES:

- 1) SOUTH ALONG A CURVE TO THE LEFT, HAVING A RADIUS OF 449.28 FEET A DISTANCE OF 201.79 FEET, THE LONG CHORD OF SAID CURVE BEARING \$25°42'39"W 200.10 FEET;
- SOUTH ALONG A CURVE TO THE LEFT HAVING A RADIUS OF 1136.28 FEET A DISTANCE OF 188.52 FEET, TO A POINT THAT IS 655 FEET WEST OF THE EAST LINE OF SAID SECTION 26; THE LONG CHORD OF SAID CURVE BEARING S8°40'04"W 188.30 FEET;
- SO 04'44"W PARALLEL WITH AND 655.0 FEET WEST OF THE EAST LINES OF SAID SECTIONS 26 AND 35, A DISTANCE OF 364.50 FEET TO THE NORTHWEST CORNER OF SAID PARCEL OF LAND CONVEYED BY UNION PACIFIC LAND RESOURCES CORPORATION TO FLEETWOOD TRAVEL TRAILERS OF OREGON, INC., BY SPECIAL WARRANTY DEED DATED OCTOBER 12, 1987;

THENCE ALONG THE WEST BOUNDARY OF SAID CONVEYED PARCEL SO 04'44"W 600.12 FEET TO THE SOUTHWEST CORNER THEREOF AND THE TRUE POINT OF BEGINNING OF THIS DESCRIPTION.
