
MINOR PARTITION PLAT NO.

SURVEYOR'S STATEMENT

NO SURVEY WAS MADE OF THIS TRACT ! The purpose of this plat is to show the approximate location of the partitioned parcel, as required by O.R.S. Chapter 92. No inspection was made on the ground. The bearings and distances shown are based on the record descriptions for this tract as provided by Abstact and Title Company. The description of the partitioned tract is as follows: Being a portion of Sections 9, 10, 15, 16, and 22, Township 4 South,

Range 39 East of the Willamette Meridian. Union County, Oregon, more particularly described as follows:

Beginning at the Northwest corner of said Section 16:

Thence: East along the North line of said section 16. 3960 feet more or less to the East 1/16 corner.

Thence: North along the west line of the SE 1/4 of the SE 1/4 of said section 9, 1150 feet more or less to the southerly right-of-way of County road No. 12.

Thence; Southeasterly along said southerly right-of-way 1430 feet more or less to the west line of said section 9.

Thence: Continuing southeasterly along said right-of-way 840

feet more or less to the North line of said section 15. Thence: Continuing southeasterly along said right-of-way 3275 feet more or less to the north line of the south 1/2 of said section 15.

Thence: East along said north line 3110 feet more or less to the East 1/4 corner of said section 15.

Thence: South 2640 feet more or less to the SE corner of said section 15.

Thence: West along the south line of said section 15, 1320 feet more or less to the E 1/16 corner.

Thence: South along the East line of the NW 1/4 of the NE 1/4 of section 22, 1320 feet more or less to the NE 1/16 corner of said section 22.

Thence: West along the south line of said NW 1/4 of the NE 1/4 of said section 22, 1320 feet more or less to the center-north 1/16 corner.

Thence: South along the center of said section 22, 1320 feet more or less to the center 1/4 corner of said section 22.

Thence: West along the center of said section 22, 2640 feet more or less to the West 1/4 corner of section 22.

Thence: North along the west line of said section 22, 850 feet more or less to a fence along the *old wood grade leading to Craig Mountain*, (Deed Book 63, page 528).

Thence: North and Northwesterly along said fence, 700 feet more or less to the said west line of section 22. Thence: North along said west line 1250 feet more or less

to the NW corner of said section 22. Thence: West along the south line of section 16, 3960 feet more or less to the West 1/16 corner.

Thence: North along the center of the SW 1/4 of said section 16, 2640 feet more or less to the center west 1/16 corner.

Thence: West along the center of said section 16, 1320 feet more or less to the West 1/4 corner of said section 16.

Thence: North along the west line of said section 16, 2640 feet more or less to the point of beginning.
