

SURVEYOR'S CERTIFICATE

I, GARY L. LANGLITZ, OREGON REGISTERED LAND SURVEYOR NO. 1099. DO HEREBY STATE THAT I HAVE PREPARED THIS MINOR LAND PARTITION IN ACCORDANCE WITH THE DESIRES OF THE PARTITIONERS AND IN ACCORDANCE WITH OREGON REVISED STATUTES, CHAPTER 92, AND THAT THE FOLLOWING DESCRIPTION IS TRUE AND CORRECT:

A PARCEL OF LAND LOCATED IN THE SOUTHWEST ONE-QUARTER OF SECTION 3, TOWNSHIP 3 SOUTH, RANGE 38 EAST, WILLAMETTE MERIDIAN, UNION COUNTY, OREGON, SAID PARCEL BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

THE WEST ONE HALF OF THE SOUTHWEST ONE-QUARTER OF SECTION 3 T.35., R.38E., W.M. SAID PARCEL BEING APPROXIMATELY DESCRIBED AS FOLLOWS: BEGINNING AT THE NORTHWEST CORNER OF THE SOUTHWEST ONE-QUARTER OF SAID SECTION 3, THENCE EAST 1320 FEET ALONG THE NORTH LINE OF SAID SOUTHWEST ONE-QUARTER OF SECTION 3 TO THE NORTHEAST CORNER OF THE WEST ONE-HALF OF SAID SOUTHWEST ONE-QUARTER, THENCE SOUTH 2640 FEET ALONG THE EAST LINE OF THE WEST ONE-HALF OF SAID SOUTHWEST ONE-QUARTER TO THE SOUTHEAST CORNER THEREOF, THENCE WEST 1320 FEET ALONG THE SOUTH LINE OF SAID WEST ONE-HALF OF THE SOUTHWEST ONE-QUARTER OF SECTION 3 TO THE SOUTHWEST CORNER OF THE SOUTHWEST ONE-QUARTER OF SAID SECTION 3, THENCE NORTH 2640 FEET ALONG THE WEST LINE OF SAID SOUTHWEST ONE-QUARTER OF SECTION 3 TO THE POINT OF BEGINNING. EXCEPTING THEREFROM ALL THAT PORTION INCLUDED IN THE RIGHT OF WAY OF WALTON ROAD AS SAID ROAD IS DESCRIBED AND DEDICATED IN MAJOR PARTITION PLAT NO. 1992-022 FILED NOVEMBER 16, 1992, IN PLAT CABINET "A", SLIDE 323, RECORDS OF UNION COUNTY, OREGON.

SURVEY NARRATIVE

THIS SURVEY AND PARTITION WAS PERFORMED AT THE REQUEST OF THE CITY OF ISLAND CITY AND WITH THE CONSENT OF THE PARTITIONER. IT IS THE INTENT OF THE CITY OF ISLAND CITY TO ACQUIRE PARCEL I OF THIS PARTITION AND THE UTILITY EASEMENT SHOWN FOR MUNICIPAL PURPOSES.

UNION COUNTY MAJOR LAND PARTITION NO. 1992-022 AND UNION COUNTY SURVEY NO. 011-1994 ARE RECENT SURVEYS WHICH DOCUMENT THE ESTABLISHMENT AND REMONUMENTATION OF THE ALIGNMENT AND RIGHT-OF-WAY FOR WALTON ROAD. THESE TWO SURVEY DOCUMENTS HAVE BEEN FOUND TO BE IN GOOD AGREEMENT WITH THE CONDITIONS IN THE FIELD. THIS PARTITION SURVEY FOR THE CITY OF ISLAND CITY UTILIZES AND CONFORMS TO THESE PRIOR SURVEYS, AND THEREFORE, NO DESCREPANCIES IN DIMENSIONS OR DESCRIPTIONS OF MONUMENTS ARE NOTED ON THIS PARTITION SURVEY.

THE SOUTH LINE OF PARCEL I IS LOCATED WITH REFERENCE TO EMILY DRIVE AS SHOWN IN AN ATTEMPT TO PROVIDE A SUITABLE LOCATION FOR THE POTENTIAL FUTURE EXTENSION OF EMILY DRIVE WESTERLY TO WALTON ROAD.

THE MAJORITY OF THE EXTERIOR OF PARCEL 2 WAS NOT SURVEYED AS A PART OF THIS PARTITION SURVEY.
