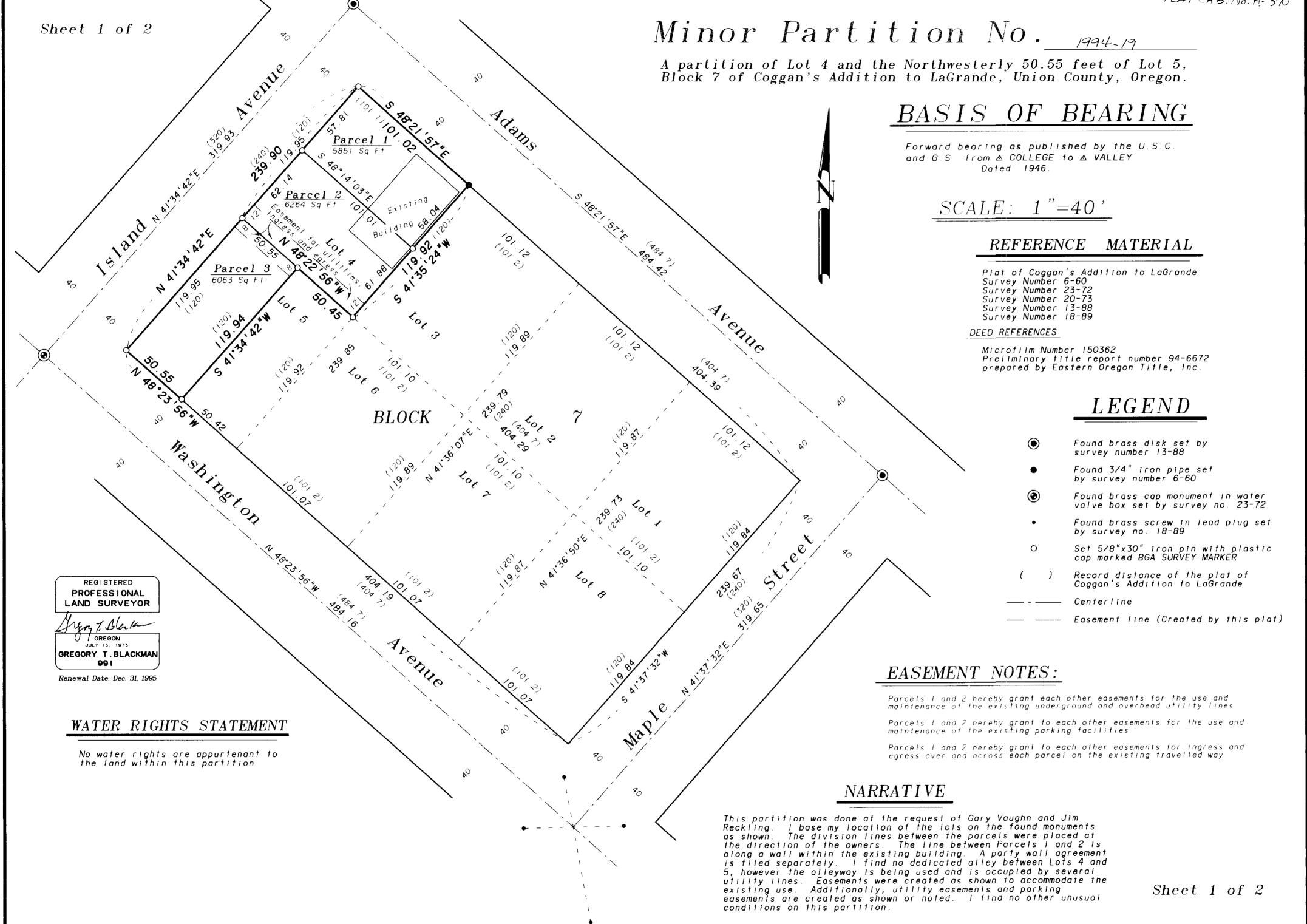

Lot 4 and the Northwesterly 50.55 feet of Lot 5, Block 7 of Coggan's Addition to LaGrande, Union County, Oregon, said tract being more particularly described as follows:

Thence: North 48°23'56" West, along said South line of said Lot 5 and the Northerly right of way line of Washington Avenue, a distance of 50.55 feet, to the Southwest corner of said Lot 5, said point also being on the Easterly right of way line of Island Avenue,

Thence: North 41°34'42" East, along said Easterly right of way line, and along the West line of said Lots 4 and 5, a distance of 239.90 feet, to the Point of Beginning of this description.
