Deed no. 134723 which was written with reference to survey 151-78 was used to establish the East line of the partition. The interior lines of the partition were placed as directed by the Grammons. An easement of record was not found for the sanitary sewer line which runs northerly-southerly across this tract. This line serves the adjoining property to the South which is owned by the Church of Christ. Mr. Glenn Henry of the Church of Christ pointed out to me approximately where the line ran.
