

NARRATIVE

This survey was made at the request of Allen Chase to locate and partition the parcel hereon shown. The survey is based on previous surveys as noted under the Reference Material. The north line was established by previous survey. The east and south lines are located on County road ROW lines. The west end is based on an unrecorded sketch of what appears to be a map of survey in which pins were set. The sketch was found in the City of Union sewer construction records. The four page sketch was drawn on "Computation Sheets" from STEVENS, THOMPSON & RUNYAN, INC. and dated 9-18-75. The sketch is titled "MAP OF PROPOSED SEWAGE TREATMENT PLANT SITE". This map shows monuments were set. We found all but one monument, all as described on said map. The bearings shown on said sketch appear to be "Grid Bearings". I find the sketch bearings must be rotated 1.51.51" clockwise to fit our bearing. This is very close to the grid Theta angle in this area. There was a survey made by James Voelz in 1966 of this parcel, MOS 066-1966. The Voelz map indicates two pins as having been set, I did not find either. This sketch of the proposed sewer plat appears to have been based on proposed sewer plat appears to have been based on the Voelz survey. I accept this sketch map as the best evidence of the position of the west end of this parcel.

I am unable to find any maps or other evidence of the location of the old Central Railroad Right of Way I accept the southwesterly side of the said "MAP OF PROPOSED SEWAGE TREATMENT PLANT SITE" as the westerly right of way line of said railroad. This is indicated on the Voelz map. I also accept the fence line along the south side of the existing railroad, running east, as the south right of way line of said railroad. I then fit a 660 foot radius curve to these tangents. I then give the railroad 50 feet of width, I also give this right of way the 10 feet as called for in the deed description, making a 60 foot wide right of way into the sewer plant. I find this fits the existing conditions very well. I find no other unusual conditions and proceed to partition as shown.
