

- 1. No occupation of parcels 1 or 2 will be allowed by the City of LaGrande until water and sewer are provided to the parcels.
- 2. The Church of Christ acknowledges that the existing 4" sanitary sewer line shown running through Parcels I and 2 will be abandoned and a new tap will be made to a new main line in 16th Street when the existing tap becomes damaged or is of no use.

NARRATIVE

This partition was done at the request of Cal Messick, on behalf of the LaGrande Church of Christ. I find the exterior of Church of Christ. I find the exterior of the property was originally monumented by survey number 23-75. I find the pins on the four corners of the exterior as shown. I place the dividing lines of the parcels at the direction of Mr. Messick. The existing fences are very harmonious as shown. There is an overhead utility line along the South line of the partition which has no easement listed in the stated title report. The well shown as encroaching on survey number 151-78 and minor partition plat number 1995-06 is still encroaching, although the well house has been removed. The existing sewer line for the church building goes through Parcels I and 2 as shown. No easement was created for this at the direction of Mr. created for this at the direction of Mr. Messick. The line will be abandoned, with a new tap provided on the future extension of the sewer line in 16th Street. I find no other unusual conditions on this partition.
