



This partition was ordered by Ted Clausen. Mr. Clausen wished to divide his parcel into two lots as shown on the annexed


The West line of Honan's addition was located by Survey number 86-78. I placed the centerline of East "O", the Northwest corner of block 6, the Southwest corner of Block 6, as well as the centerline of East 'N' avenue by single proportionate measure along the West line of said addition. I then establish the centerline of North Willow by driving a straight line from the centerline monument in East "O" and North Willow, as established by ties from Minor Partition 1996-10, to the brass plaque monument in East "L" and North Willow, as established by survey number 6-81. I then drive a line from the centerline of East "O" at the west line of said Honan's Addition to the centerline of at the west line of said Honan's Addition to the centerline of East 'O' and North Willow. I then single proportion the centerline of East 'O' and North Willow by single proportion from the center of East 'O' and North Willow to the brass plaque in North Willow and East 'L' Avenue. I then establish the Northeast, and the Southeast corners of Block 6 by intersect 30 feet from the center lines of East 'O', East 'N' and North Willow streets. I then establish the lot corners within Block 6 in a standard single proportion manner.

then establish the lot corners within Block 6 in a standard single proportion manner. I establish the Southwest corner of Lot 1 by straight line intersect from the respective lot corners lying along the street lines.

I noted that at one time all of Lot 1 was owned by Mary J. Glass. She sold the South 42.5 feet of Lot 1 to Andrew Sundman. Deed Volume 60, page 423. She also sold a strip of land 50 feet in width and 119.5 feet long along the West line of Lot 1 to Eva May Parker. Deed Volume 63 page 255, leaving Mrs. Glass the remanent of Lot 1. I find that there is 149.12 feet instead of an apparent 150 feet along the North line of Lot 1, and 127.45 feet instead of 127.5 feet along the East line of Lot 1.

Mr. Clausen instructed me to create a 10 foot sanitary sewer easement across Parcel 2 to accommodate a sewer line to Parcel 1.
