# *NARRATIVE*

This partition was done at the request of Anthony and Sarah MacDonald, owners of the partitioned land. This area has been partitioned many times. These parcels were originally partitioned in this configuration by Minor Partition 1997-01. That plat was later modified by Minor Partition 1998-02, making the land within this partition a single parcel (Parcel 1 of Minor Partition 1998-02). I found all of the monuments set by the previous partitions as shown. I find an encroachment of a fence along the South line of Parcel 1 of this partition. The fence was constructed from the Southwest corner of the parcel on a line to the pin marking the curve point of the cul-de-sac, rather than the true intersect approximately 20 feet West. There is also an underground sprinkler line that encroaches approximately 0.5 ft. at the pin marking the true Southeast corner of Parcel 1. I find no other unusual conditions on this partition.
