NARRATIVE

This partition was performed at the request of Mr. Bonney. Mr. Bonney wanted to split his ownership into two parcels. Block 24 of M.A. STEVENSON'S ADDITION was located by Survey No. 150-78, 36-79, and 37-79. I accept said Surveys placement of Block 24. Mr. Bonney's ownership is the last in a chain of sequential deeds and receives the remaining portion of Block 24. The first portion of Block 24 to be conveyed was a 100' x 50' parcel in the Southwest corner to Galloway by Deed Book 134 Page 474. I give this ownership its full measure. The next parcel was conveyed by Deed Book 155 Page 371 to Townsend. It is described as the "Northwest 1/4 of Block 24" and receives its full measure. The next parcel out was conveyed by Harper to Ralph Knight by Microfilm No. MF#70934 and is described as "The North 62.5 ft. of the East 100 ft...". This ownership is not a full 100 ft. because the Northwest 1/4 was already deeded and Harper did not own it. The last deed out was Microfilm No. MF#70935. It is described as "The South 62.5 ft. of the North 125 ft...". This deed also measures close to 98 ft. instead of 100 ft. Once the ownership goes into the South 1/2 of the lot the full 100 ft. is given. Mr. Bonney quitclaimed 2.5 feet of the Northeast portion of his property. Fences are away from the property lines as shown. I find no other problems with this partition.
