NARRATIVE

This partition was done at the request of Gary Haefer, on behalf of the owner of the land within this partition. The location of this partition is based on Union County survey number 22-83, which located Swackhamer's Addition in it's entirety. Minor Partition Plat Number 1992-09 then located the South half of Block 15 on that basis. I recovered the monuments from that survey and partition as shown. I place the North half of Block 15 from that information. The exterior of the partition is described as the North half of Block 15 by deed. I place the dividing line between the two parcels at the direction of Mr. Haefer. I place the triangular portion granted to ODOT on the West side of the block by rotating the positions given by state plane coordinate on survey number 054-1998 from the intersections of Main and Grape and Main and Delta. These are the two intersections shown on the 1998 survey that directly relate to survey number 22-83. I then place the centerline of the highway alignment (not coincidental to the platted right of way) at the record position of survey number 054-1998 rotated to this basis of bearing. I find the existing fence line to be away from the true deed line as shown. I also find a barn to encroach at the Northeast corner of this partition. I find no other unusual conditions on this partition.
