This partition was ordered by Sue Ellen Baker in order to create two lots in order to create and sell a 2.5 acre parcel. I find that this property was surveyed several times, and I found various monuments as shown. I accept the monuments along the South line of the Baker tract as set by Survey Number 18-74. I project the South line as monumented to the East to intersect the Center of Section line, and find that the deed call from the South 1/4 corner of Section 32 differs from the field ties by 0.82 feet. The deed calls a distance of 1524.00, actual measurement from the South Quarter corner is 1523.18 feet. I held the found monuments as set by Survey 18-74 because the South Quarter corner has been reset several times due to construction, and I felt that I should place the error where is occurred. I place Blackhawk Trail from found monuments set by the original Plat of Proebstel Tracts. I find deed Book 149 Page 313 conveys to Sue Ellen Baker land to the "Subdivisional line (SE1/4, SW1/4 of Section 32)", and then runs northerly along the subdivisional line to the centerline of Blackhawk Trail. I find that the southwest corner of the Southeast 1/4 of the Southwest 1/4 was set in 1922 by McLain. I find a 3/4" pipe that was set by the McLain Survey, and break Section 32 using the found monuments as shown. The subdivisional line does not fit the existing West fence and the various surveys filed on the Baker West property line by approximately 6 feet. I find that Baker actually extends West of the fence approximately 6.00 feet. Ms. Baker filed a deed to Nearing (document Number 20043118) conveying all her interest in the property lying West of the existing fence. I find no other unusual conditions on this survey.
