Preliminary Title Report Number 06—17561 dated June 27, 2006 prepared by Eastern Oregon Title, Inc.

NARRATIVE

This partition was done at the request of Gary Haefer, on behalf of the owner of the land within this partition. The tracts within the Northwest quarter of the Southwest quarter of Section 19 are all described by metes and bounds, with Third Street being a remnant. I place the North and South lines of this partition parallel with the North line of the Southwest guarter of Section 19, and the East line of the partition parallel with the West line of Section 19, as was the convention with Minor Partition Plat Number 20050001T. The deeds for the tracts North of this partition begin at the quarter corner to the North, and the deeds South of this partition begin at the South 1/16th corner between Sections 19 and 24. The North-South dimension of the deeds add up to exactly 1320 feet, making no allowance for the excess within the quarter section. In order to best place the excess with the existing lines of occupancy, I treat the furthest South tract as a remnant, throwing all of the excess into the Southerly tract. I feel that is the best available evidence of the intent of the deeds, as indicated by the lines of occupancy within this quarter section. place the line between Parcels 1 and 2 at a position as directed by the owner. find no other unusual conditions on this survey.
