

This partition was done at the request of Gust Tsiatsos in order to partition the existing tract of land into three separate parcels. I use the subdivision of section 34 which was done by survey number 6-89 to locate the North line. Minor Partition number 2001–021 located and monumented the South line and the Plat of CLEARWATER POND SUBDIVISION places the West line. place the South 69.55 feet of the East line of the tract by the record position of Minor Partition number 2001-021, as the existing monument North of the Southeast corner of the tract has been disturbed. I then drive a line from the position as established, North to the intersection of the centerline of Fruitdale Lane at a point 16 rods East of the West property line as per the original deed call. I establish the configuration of the new parcels at the direction of Mr. Tsiatsos. This tract of land is subject to a 10 foot access easement along the entire East line of said tract to the La Grande Concrete Pipe Company. I find no other unusual conditions with this plat.
