IN TOWNSHIP 4 SOUTH, RANGE 35 EAST OF THE WILLAMETTE MERIDIAN, UNION COUNTY, OREGON:

SECTION 9: THE ENTIRE SOUTHEAST QUARTER.

SECTION 15: THE ENTIRE SOUTHWEST QUARTER AND THE SOUTH HALF OF THE NORTHWEST QUARTER.

SECTION 16: THE ENTIRE EAST HALF, THE EAST HALF OF WEST HALF, THE WEST HALF OF SOUTHWEST QUARTER AND THE SOUTHWEST QUARTER OF NORTHWEST QUARTER.

SECTION 21: ALL THAT PORTION OF THE EAST HALF LYING EAST OF THE CENTER OF THE COUNTY ROAD RUNNING IN A GENERALLY NORTH AND SOUTH DIRECTION ACROSS SAID SUBDIVISION.

SECTION 22: THE ENTIRE SECTION.

SECTION 23: THE WEST HALF OF NORTHWEST QUARTER.

ALL SITUATED IN THE COUNTY OF UNION, STATE OF OREGON.

SUBJECT TO THE FOLLOWING:

1. THE RIGHT-OF-WAY OF UNION COUNTY ROAD NO. 1, (MCINTYRE ROAD) ACROSS THE PROPERTY.

2. RIGHTS OF THE PUBLIC IN AND TO THAT PORTION OF THE PROPERTY LYING BELOW THE HIGH WATER MARK OF FLY CREEK, AND OTHER UNNAMED CREEKS, AS THEY CROSS THE PROPERTY.

3. EASEMENT RIGHTS OF WAY, AS RESERVED BY MOUNT EMILY LUMBER COMPANY, A CORPORATION. IN DEED, INCLUDING THE TERMS AND PROVISIONS THEREOF, GRANTED TO FRED HOILTKE, DATED OCTOBER 4, 1937, RECORDED OCTOBER 8, 1937, IN BOOK 98, PAGE 272, DEED RECORDS OF UNION COUNTY, OREGON, FOR RAILROADS, ROADS AND TELEPHONE LINES ACROSS THE PROPERTY.

SURVEYORS NOTE: THE ONLY PORTION OF THIS EASEMENT WHICH APPLIES TO THE PARTITIONED PROPERTY IS IN SECTION 21. THE PORTION OF SECTION 21 CITED IN THE DESCRIPTION IS THAT PART OF THE W1/2 SE1/4 WEST OF THE "STARKEY SHEEP RANCH ROAD". THE "STARKEY SHEEP RANCH ROAD" IS BELIEVED TO BE THE SAME AS THE STOCK DRIVE OR "COUNTY ROAD" REFERENCE CONTAINED IN THE DEEDS. BECAUSE OF UNCERTAINTY IN THE LOCATION OF THE "STARKEY SHEEP RANCH ROAD", I HAVE INDICATED THIS EASEMENT MAY APPLY TO THE PORTION OF W1/2 SE1/4 OF SECTION 21 WITHIN THE PARTITIONED PROPERTY, ON SHEET 1 OF 2.
