Thence; South 89°51'02" West, parallel with the North line of said Section 5, a distance of 400.00 feet, to the Northeast corner of Parcel A conveyed by microfilm number 20071128 of the deed records of Union County.

Thence; South 0°42'17" East, along the East line of said Parcel A, a distance of 210.00 feet, to an angle point in said Parcel A,

Thence; South 89°51'02" West, along the exterior of said Parcel A, a distance of 80.00 feet, to an angle point in said exterior,

Thence; North 0°42'17" West, along the exterior of said Parcel A. a distance of 4.99 feet, to an angle point in said exterior, said point being the center line of the arm or channel of Grande Ronde River through which the May Park Water Company and the Grande Ronde Valley Irrigation Company divert water from the main channel of Grande Ronde River,

Thence; North 78°57'06" West, along said exterior and along said channel, a distance of 15.08 feet, to an angle point in said exterior,

Thence: South 0°42'17" East, a distance of 119.83 feet, to the North right of way line of May Lane, said point being the point of curvature of a 2566.83 ft. radius curve right,
