

NARRATIVE

This partition was done at the request of Jeff Hines, Vice President of HNS, Inc., owner of the land within this partition. Mr. Hines wanted to create a 4 acre parcel on the Southerly portion of the existing ownership. This plat also creates a 15 ft. water line easement across Parcel 1 for the use of Parcel 2, so that Parcel 2 could be served from the existing water line in Industrial Lane. I use the existing monumentation to control the exterior of the partition. The monument at the Northeast corner of Parcel 2 of Minor Partition Plat Number 2000-16 was destroyed. I replaced this monument at the record position of the existing partitions. This partition has an existing utility easement by microfilm number 982687. As is common with easements written by OTEC, the description calls a specific placement by bearing and distance with the language of "as constructed on the ground". In this case, the placement of the easement by the legal description falls approximately 50 feet North and 60 feet East of the position of the transformer. I show the easement at the as constructed location. The fences are at or very near the property lines of this partition. I find no other unusual conditions on this partition.
