

NARRATIVE

This partition was done at the request of Joaquin Grant, potential purchaser of the land within and agent of the landowner. I place the dividing line at the direction of Mr. Grant and the landowner. Exteriors of the block were placed by Survey Number 067–2015 and differs slightly from the block dimensions used in Partition Plat 1996–10. I find original monuments marking partition corner relatively harmonious with the plat with the exception of the Northwest corner of Parcel 2 which appears disturbed by fence construction. I use the platted position for this corner. Fencelines have been reconstructed since Partition 1996–10 to coincide with title lines. This may account for minor positional discrepancies in pin locations.

I find no other unusual conditions with this partition.
