
PARTITION PLAT NUMBER 20170003T

NARRATIVE

This partition was done at the request of Patty Glaze on behalf of Barbara Johnson, executor for the estate of Joanne Price. This partition is UNSURVEYED. No attempt was made to locate monuments or property lines on the ground. However, the exteriors of the property as well as a section subdivision was resolved in Survey Number 58—77 and I base all bearings, distances, acreages and placement of Mt. Glen Road on this survey. The division line was placed at the direction of Ms. Glaze. I find no unusual conditions with this partition.


