

The purpose of this partition is to validate both parcels as per ORS 92.176, as well as adjust the common line between the two properties. The exterior of the properties was surveyed in Survey Number 018-2014, and all courses are based on this survey. I find no unusual conditions with this partition.




BASIS OF BEARING


