
PARTITION PLAT NUMBER 2020-0002

NARRATIVE

This partition was done at the request of Scott Nebeker, owner of the land within. Mr. Nebeker wanted to adjust the common line between Parcels 1 and 2 as shown. This partition is UNSURVEYED. No attempt was made to locate property boundaries on the ground. Bearings and distances are based on Partition Plat 2002—014. Tie to the South quarter corner of Section 9 is based on computed value as per Partition Plat 1992—13. I place the dividing line at the direction of Mr. Nebeker. I find no unusual conditions with this partition.
