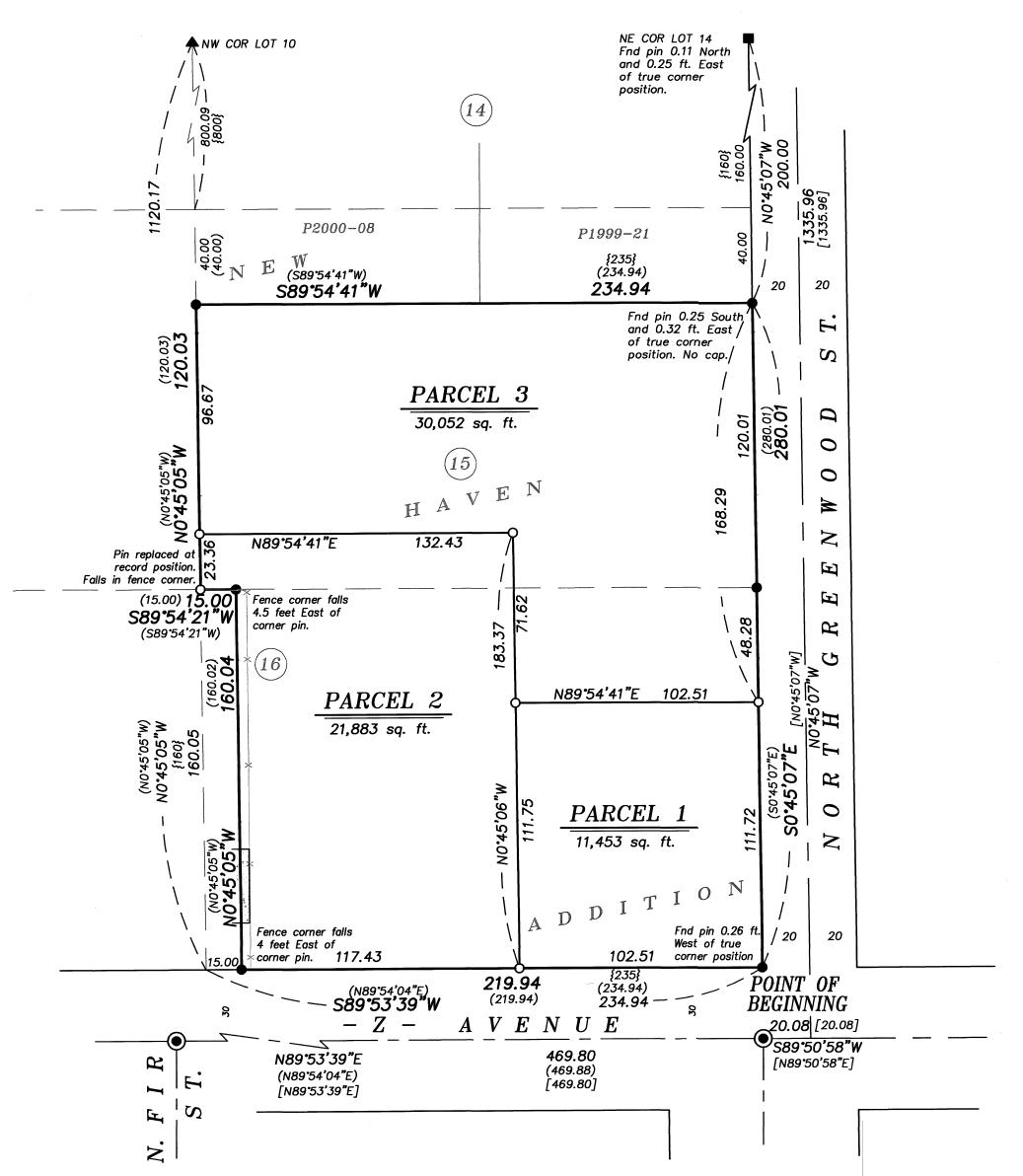

NARRATIVE

This partition was done at the request of Randy McKinnis, owner of the land within. Mr. McKinnis wanted to divide the property as shown. The exteriors were monumented by Survey Number 029–1999. I recover the monuments and find several of them along Greenwood Street out of position, as was also noted on Partition Plat 20190011T. A monument along the West side of the property has been removed, most likely by fence construction. I replace this at position as per Survey 029–1999. I place the division line at the direction of Mr. McKinnis. There is a fenceline encroachment along the South side of the West line, as noted. Portions of the concrete driveway alongside this fence also encroach as shown. I find no other unusual conditions with this partition.
