

Situated in the Northwest quarter of the Northeast quarter of Section 6, Township 3 South, Range 38 East of the Willamette Meridian Being a portion of Lots 1, 2, and 3, Block 45 of Riverside Addition, with alleys and streets that have accrued by way of vacation, City of La Grande, Union County, Oregon



40 feet off the monument at this Southwest corner of Block 45 to place the intersection of Lane Ave., and Alder Street. Along the Alder Street centerline, I use a proportionate position to place the intersection of Benton Ave. Placement as such is harmonious with monumentation set by Surveys 009–1994 and 46–78 and with record measurements of Survey 106-78. Lots were established by standard proportion, and are harmonious with existing monumentation. I place the dividing line at the direction of Mr. Goodman. I find no unusual conditions with this survey.


