

NOTES AND EASEMENTS

Easement, granted to Eastern Oregon Light and Power Co., by Book 83, Page 96, for down guy. No power lines or guy wires were observed on property at time of survey.

NARRATIVE

This partition was done at the request of Kent McCall, on behalf of the Nazarene Church. Mr. McCall wanted to divide the property as shown. I recover monuments as shown. The Northeast corner pin appears to have been disturbed by the setting of a steel fence post, the remnants which occupies the corner position. This fence post is not the one that supports the current wood fence, which encroaches as shown. Several of the pins in this area have shown evidence of disturbance. The positions of the pins that can be ascertained match the record very well.

A landscape wall encroaches slightly at the SE corner, and is built over the existing pin. I find no other unusual conditions with this partition.
