

NARRATIVE

This partition was done at the request of Coby Joseph, on behalf of the owner of the land within. Mr. Joseph wanted to divide the property as shown. Survey 22–83 monumented select intersections within Swackhamer's 2nd Addition. I recover monuments as shown and find them harmonious with the map. I place the non-monumented intersection positions at midpoint between monuments. I place the dividing line at the direction of Mr. Joseph. Fencelines are off as shown. I find no unusual conditions with this partition.



BASIS OF BEARING

Solar observation taken at the Northwest corner of Section 19, Township 4 South, Range 40 East of the Willamette Meridian.
