

CERTIFIED RECORD OF LAND CORNER MONUMENTATION

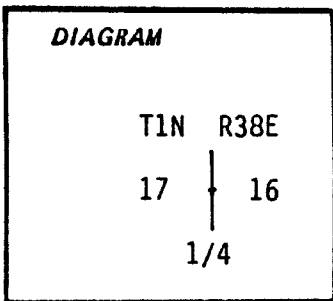
History of original corner establishment:

Original survey by J.R. Kimbrell, Contract No. 352, June, 1891.

Set a stone 22x10x7 ins., 17 ins. in the ground for 1/4 sec. cor., marked 1/4 on West face, from which:

1/4 A Pine, 24 ins. dia. bears N10°W 9 lks. dist., marked S BT.

A Pine 9 ins. dia. bears S9°E 32 lks. dist., marked 1/4 S BT.



Description of corner evidence found:

Found the original corner monument, a basalt stone, 18"x13"x10", firmly in place in a mound of stone 3' dia. and one-half foot high, with faint chisel markings "1/4" visible on the West face,

From which:

The remains of the original NW Bearing Tree, a Ponderosa Pine stump, decayed, size indeterminate, with axe marks on the side facing the corner monument and scribing "BT" on a wood slab lying at the base of the stump, bears N10°W 5.9 feet to the blazed face.

The original SE Bearing Tree was not found.

Description of monument and accessories established to perpetuate the original location of this corner:

At the position of the original corner monument, we set a 2"x30" Aluminum Pipe, 28" in the ground on a Southwest slope, with aluminum cap marked:

The original corner stone was placed face down along the West side of the Aluminum Pipe. We rebuilt a mound of stone 3 ft. dia. and 1 foot high around the Aluminum Monument.

We mark new Bearing Trees as follows:

A 12" Ponderosa Pine, scribed "1/4 S16 BT" on a double blaze bears S78°E 38.5 feet.

And a 16" Ponderosa Pine, scribed "1/4 17 BT" on a double blaze, bears S58°W 17.4 feet.

Note: The letter "S" was not scribed on this BT.

Attached brass washers, marked "LS 1099" to lower blaze of new BT's. Magnetic compass (Declination 20° East) Steel Tape.

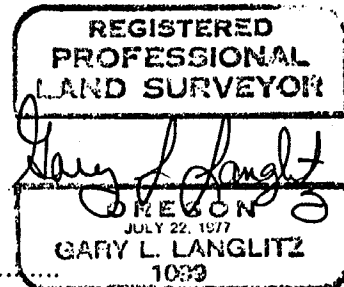
Corner located approx. 300' NE of Dry Creek Road.
