

Found a brass cap marked as shown below, and 3 live and vigous BTs as per record. NE bt is dead and down.

Painted a 6" red band around all BTs and attached Bearing Tree signs.

Found the Northeast bearing tree dead and down, Blaze evident but scribes not visible as the tree is partially burned. Tree was at record distance from existing fence corner.

Found SW bt dead and down, two blazes evident but scribes not visible because of fire damage


Found NW bt stump at record bearing and distance from fence corner. Tree is burnt to a small stump no blazes visible or scribes visible.
