

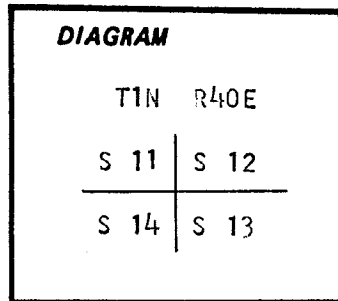
CERTIFIED RECORD OF LAND CORNER MONUMENTATION

**History of original corner establishment:**

Corner originally established by William H. Odell and Joseph G. Gray under glo joint contract number 120, dated May 27, 1867  
Surveyor General record states:

Set post cor for Secs 11,12,13 & 14 from which:

- A pine 20 in dia bears S70°W 97 lks
- A pine 6 in dia bears N50°W 80 lks
- A pine 28 in dia bears N30°E 63 lks
- A pine 24 in dia bears S75°E 98 lks



**Description of corner evidence found:**

- Found 20 inch m/1 pine stump N30°E 19.8 feet no scribes visible
- Found 20 inch m/1 pine stump S75°E 49.5 feet no scribes visible
- Found 20 inch m/1 pine stump S70°W 64.0 feet no scribes visible

**Description of monument and accessories I established to perpetuate the**

**original location of this corner:** At record bearing and distance from the above BTs, I set a 2½ inch x 30 inch aluminum pipe with aluminum cap marked as shown, 25 inches in the ground from which:

**New BTs**

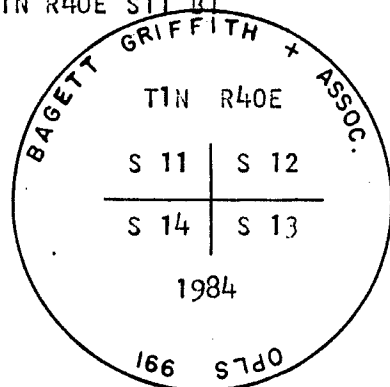
- A 8 inch diameter tamarack bears N30°E, 16.1 feet marked T1N R40E S12 BT
- A 10 inch diameter tamarack bears S2°E, 5.0 feet marked T1N R40E S13 BT
- A 14 inch diameter P.Pine bears S77°W, 28.1 feet, marked T1N R40E S14 BT
- A 12 inch diameter P.Pine bears N75°W, 36.0 feet, marked T1N R40E S11 BT
