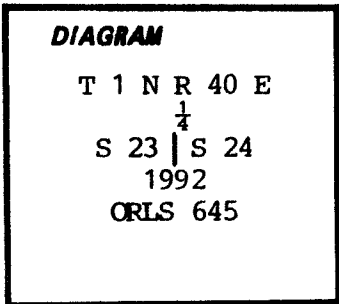


CERTIFIED RECORD OF LAND CORNER MONUMENTATION

History of original corner establishment:

This  $\frac{1}{4}$  Section Corner was set by deputy surveyor William H. Odell, under Contract No. 120, dated May 27, 1867. He states he set a  $\frac{1}{4}$  sec. post, from which he set bearing trees:  
 A pine 18 in. dia. bears N 26 W, 75 lks. distance.  
 A pine 24 in. dia. bears N 20 E, 125 lks. distance.



Description of corner evidence found:

At the assumed  $\frac{1}{4}$  section corner location I found four small stones that appeared placed, from which I found evidence of two bearing trees:  
 A badly rotted stump approximately 26 in. dia. bears N 31 00 W, 49.50 ft. (75 lks) dist. with a part of a pitch face with visible scribing  $\frac{1}{4}$ S.  
 A stump hole with portions of rotted pine stump which bears N 16 00 E, 82.50 ft. (125 lks).

Description of monument and accessories I established to perpetuate the original location of this corner:

Using the evidence I found as being the original  $\frac{1}{4}$  Sec. Corner location, I set a  $2\frac{1}{2}$ " brass cap on a 30 in. pipe to within 4 in. above the surface of the ground. I placed a mound of stone 3 feet dia. and 1 foot high around the monument. The cap being stamped as shown in the above diagram. I then set four new bearing trees as follows:  
 A Ponderosa pine 6 in. dia. bears N 43 15 W, 32.75 feet scribed  $\frac{1}{4}$ S S 23 BT.  
 A Ponderosa pine 6 in. dia. bears S 32 00 W, 12.30 feet scribed  $\frac{1}{4}$ S S 23 BT.  
 A Ponderosa pine 7 in. dia. bears N 52 45 E, 36.40 feet scribed  $\frac{1}{4}$ S S 24 BT.  
 A Ponderosa pine 7 in. dia. bears S 22 00 E, 13.40 feet scribed  $\frac{1}{4}$ S S 24 BT.
